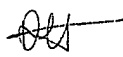

DRAFT ORDER

UPON the Application notice dated 3 February 2022 for a block transfer order under Chapter 6 (sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (the Insolvency Rules)

AND UPON reading the Witness Statement of Adam David Harris dated 3 February 2022, the Consents to Act from the First to Fifth Applicants and the Consent to Removal from the First Respondent

AND UPON the Secretary of State having been given notice on 3 February 2022

AND UPON the court determining the application without a hearing

IT IS ORDERED THAT:

1. The Applicants have leave to make a composite application in respect of the insolvency proceedings identified in the Schedule (attached to this order).
2. Such of the insolvency proceedings set out in the Schedule that are proceeding in any court other than this court be transferred to this court for the purposes of this application and order. Thereafter, and immediately upon this order taking effect, those cases be transferred back to their original court.
3. Neil John Mather (Outgoing office-holder) be removed from office in respect of each of the cases listed in Parts I and II of the Schedule (Block transfer cases) from the date of this order.
4. Each of Adam David Harris, Guy Robert Thomas Hollander, Michael Pallott, Natasha Brodie and Simon Chandler (Replacement office-holders) be appointed as replacement office-holders in respect of each of the Block transfer cases listed against their name in Parts I and II of the Schedule from the date of this order, as summarised below:
 - a. Adam David Harris – Part II (A)(i), (B)(i), (C)(i) and (D)(i)
 - b. Guy Robert Thomas Hollander – Part II (A)(iii) and (B)(ii) and (D)(ii)
 - c. Michael Pallott – Part II (A)(ii) and (B)(iii)
 - d. Simon Chandler – Part II (C)(ii)
 - e. Natasha Brodie and Adam David Harris jointly – Part I (A)(i)

5. The Second to Twelfth Respondents, whom are currently the joint office-holders with the First Respondent/Outgoing office-holder in relation to the cases listed in Part II of the Schedule, do remain the joint office-holders to those cases.
6. In relation to the cases listed in Parts I and II of the Schedule the joint office holders be authorised to carry out any act together or by either of them.
7. In respect of any existing Court applications or proceedings arising out of any of the matters listed in the Schedule, the Replacement office-holders shall be substituted for the Outgoing office-holder by virtue of this Order and pursuant to Rule 12.37(1)(e) of The Insolvency (England and Wales) Rules 2016 (the Insolvency Rules).
8. Where the Outgoing office-holder is removed and replaced as administrator in respect of those companies listed in Part II (D) of the Schedule the Proposals (and resolutions contained therein) to creditors shall be read as if the relevant Replacement office-holder was originally stated in place of the Outgoing office-holder. Where those administrations are subsequently converted into CVLs, the replacement administrator in each case shall also replace the Outgoing office-holders liquidator without the need for further creditor approval or steps.
9. The creditors (and in the case of solvent liquidations, the members) in each of the block transfer cases listed in the Schedule be notified of this order, and the provision for liberty to apply set out herein at paragraph 11 below, by one composite Advertisement published in the London Gazette (Advertisement) within 28 days from the date of the order.
10. The office-holders then holding office shall deliver notice of this Order to creditors (or in the case of solvent liquidations, members) of the estates in the Schedule within the next progress report prepared and delivered in accordance with the Insolvency Rules, together with an explanation of the effect of the Order.
11. Any creditor, or, in the case of any members' voluntary liquidation, any member, of any case in the Schedule who has an objection to this order shall have 28 days from the date of the Advertisement to apply to court to set aside or vary the terms of this order. Such application(s) shall not affect the transfer of the Block transfer cases listed in the Schedule until further or other order by the court.
12. The Replacement office-holders shall give notice to the Secretary of State and, in the case of Companies, the Registrar of Companies in respect of the relevant insolvency proceedings listed in the Schedule of the terms of this order as soon as reasonably practicable.
13. The Outgoing office-holder shall file a copy of this order with each of the courts listed in the Schedule.

14. Nothing in this order shall release the Outgoing office-holder from any obligation to give and file notices in respect of the office-holder's removal under this order in respect of the block transfer cases listed in the Schedule.
15. Following the removal of the Outgoing office-holder from his office as Joint Administrator, Liquidator and Joint Liquidator (as specified in the Schedule) he shall be released and discharged from any liability as office-holder in respect of all the estates listed in the Schedule, such release/discharge being effective 35 days from the date of the Advertisement and without needing to comply with any requirements set down in the Insolvency Act 1986 or the Insolvency Rules save that such release/discharge may be subject to further order in the event of an application by any creditor or member under paragraph 11 above for the specific case subject to that application.
16. The period to be covered by the progress reports to members and/or creditors in respect of the estates listed in the Schedule shall not be altered by the virtue of the making of this Order.
17. The parties have liberty to apply to Court to amend this order to include any appointments held by the Outgoing office-holder which have been inadvertently omitted from this Application.
18. The costs of this application, including VAT, shall be paid by Mazars LLP.
