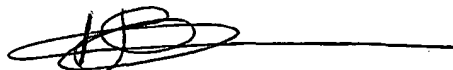

1 Accounting policies

The company is a private company incorporated, domiciled and registered in the UK. The registered number is 00033525 and the registered address is One Southampton Row, London, United Kingdom, WC1B 5HA.

These financial statements were prepared in accordance with Financial Reporting Standard 101 *The Reduced Disclosure Framework* ("FRS 101") as issued in August 2014.
