 - (a) In clause 1 by the deletion of the words "Public Limited Company" and by substituting the word "Limited";
 - (b) By deleting clause 2;
 - (c) By renumbering clauses 3 6 as clauses 2 5.
- That existing clause 3 of the Memorandum (as re-numbered clause 2 pursuant to Resolution 1(c) above) be amended by deleting therefrom the words "Wales" and by substituting therefor the words "England and Wales".
- That the provisions of the Memorandum with respect to its objects be altered by deleting the whole of the former clause 4 (as re-numbered clause 3 pursuant to Resolution 1(c) above) and substituting clause 3 as set out in a form annexed to this Resolution and for the purposes of identification initialled by the Chairman.
- That the Articles of Association contained in the printed document (a copy of which is attached hereto for the purposes of identification initialled by the Chairman) be and the same are approved and adopted in substitution for and to the exclusion of all the existing Articles of Association of the Company.
