That the right of the holder of the Irredeemable Preference Shares of the Company to receive a cumulative preferential dividend in priority to any other dividend declared by the Company out of its profits available for distribution, pursuant to Article 3B 1 1 of the Company's articles of association, be and hereby is unconditionally and irrevocably waived for the purpose of enabling the directors of the Company to declare an interim dividend in specie of assets in respect of the year ending 31 December 2007 in favour of the holder of the Company's ordinary shares, Vantas International Limited, such dividend comprising (1) the right to receive an investment of the equivalent of EUR 286,610,836 02 (subsequently converted to GBP 226,772,798 89) made by Cadbury Schweppes Investments B V ("CSIBV") with Cadbury Schweppes Finance P L C ("CSF pic"), pursuant to the terms of an investment agreement entered into between CSIBV and CSF pic on 1 May, 2008, (2) the right to be paid all amounts owed by Cadbury Schweppes Limited ("CS Ltd") pursuant to the terms of a debt repayment deed entered into between CS Ltd and CSIBV on 7 May, 2008 in consideration for the sale by CSIBV to CS Ltd of the entire issued share capital of Cadbury Schweppes Americas Inc ("CSAI"), and (3) the right to be repaid all amounts owed by CSAI under six loan agreements that were entered into between Cadbury Schweppes Americas Holdings B V (as the lender) and CSAI (as the borrower) on 14 February 2007
