Trustees Responsibility for the Financial Statements

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Society and of its income and expenditure for that period. In preparing those financial statements, the trustees are required to:-

- select suitable accounting policies and apply them consistently;
- make judgments and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue to operate.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Companies Act 1985. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

TRUSTEES REPORT

The Trustees present their report and the financial accounts for the year ended 31 December 1998 which have been prepared in accordance with current statutory requirements and the charity's governing documents.

The objectives of the charity remain the promotion of interest in the life and works and preservation of artifacts of whatever nature of the Brontë family and the establishment and maintenance of a permanent museum for the benefit and enjoyment of the public.

The charity is run on a day-to-day basis by paid employees but the overall management and strategy control is in the hands of the Council Members who act on a voluntary basis.

The names of the Trustees and their advisers during the year are included in the section on significant Information on Page 1.

The Report of Council includes a review of the development, activities and achievements of the charity during the year.

The Statement of Financial Activities and Balance Sheet show the transactions and financial position of the charity - the main features are the loss incurred for the year which is causing continuing concern for the management personnel and Council.

We have also redesignated the Reserves to show the projected purposes for which the Society holds its cash funds. The reserves policy of the Society is to build up such designated funds to a level where it can fulfil its development plans.

REPORT OF COUNCIL 1998-99

I feel inclined to begin this year's report with an aspect of the Society's work that is extensively covered in the *Gazette* but sometimes gets sidelined in the Reports of Council, that is our membership activities.

Memorial Services

In the closing months of 1998 we held two memorial services in Haworth Parish Church, one for Branwell, one for Emily on the 150th anniversaries of their deaths. Both services were extremely well attended, and I believe kept a fitting balance by on the one hand lamenting the early death and on the other celebrating the promise and achievement of their lives. Ahead of us, in May, is a wreath-laying ceremony in Poets' Corner, Westminster Abbey, with a speaker and readings.

Preceding Evensong and the wreath-laying will be tea in the House of Lords and the House of Commons, for which no less than two hundred members have applied for tickets. It is obvious there will be a formidable number of Brontëans in the Abbey - one wonders if there have been any literary anniversaries there that have attracted so many. Our thanks are due to Tom Winnifrith for masterminding the services, and to Ruth Battye and Jill Greenwood for coping with the tremendous demand for tickets, and with the social side of the arrangements.

Conference

The Conference, held in Leeds, was the third such event organised by Catherine Rayner, who, sadly, did not stand for Council last year due to the pressures of work and ill-health. It was brilliantly successful, and the standard of lectures and discussion was as high as it has ever been. It was particularly pleasing that so fine a balance was held between international speakers - including German, American and Japanese lecturers - and British ones. The attenders were equally varied in nationality, and emphasized what has been apparent since the early days of the Brontës' fame: the universality of their appeal. Having Beryl Bainbridge at dinner talking about her own writing and its debt to the Brontës was a wonderful extra.

Council Business

Matters coming before Council have been as varied as always, and if I have occasionally sighed that the Brontës themselves get too small a look-in, this may be when few items of interest come on to the market, or when they fetch prices way beyond our reach. The latter has been the case twice this year, presenting us with a dilemma both practical and moral: we want Brontë items, and regard the Parsonage Museum as their natural home, but can we justify spending so large a proportion of our reserves on, for example, a single letter, and are we helping to perpetuate an inflated market price?

We have had many issues of an environmental nature to consider, including the proposed Branwell (hastily respelled after being announced as Branwell) retail centre in Rawdon Road. The new carpeting for the dining room was a non-controversial matter, and has been generally liked, but the proposed changes in the Bonnell Room, involving a new secure storage area and a more user- (and disabled-) friendly display did not attract universal consent. One understands the instinct to stand still (many seem to wish that time had stood still round about the time they first

visited the Parsonage and saw its treasures), but in one area that is both undesirable and impossible: we must be in the forefront of progress in the care for the objects in our collection, and we must do all possible to protect them from outside threat. Recent events in the museums and galleries world would have made some such possible threats all too evident.

Management Structure

We have been fortunate during the year in having Martin Plimley, who previously offered us splendid assistance with the Strategic Plan, to prepare a report on management structures at the Parsonage Museum and the Society's offices. We now employ a large number of people, full and part time, and it is important to have in place the best possible structure of command and "reporting" to make the most effective use of them. We are grateful to Business in the Arts for introducing Martin to us, and facilitating his work. His report will be discussed at the February Council meeting.

Buildings Committee

A Buildings Committee was set up in September, chaired by Dudley Green. It has met frequently throughout the year, with the aim of getting a clear statement of the Museum and Society's needs in terms of space and facilities. We aimed to have the widest range of opinions and feelings about building options represented on this Committee, and it is working most effectively. A report will be presented at the AGM.

People

The 1998 elections brought us two new Council members, Joan Bellamy and Angela Crow, and one returning one, Geraldine Robertson-Brown. They are all very welcome. There have been changes at the Museum, including the retirement of Mary Woolridge, the Shop Manageress: we are grateful for her many years of superb work for us, and we wish her well in her new home in Cornwall. We welcome Stephanie Angus, formerly her deputy, as her successor. We are also about to appoint a successor to Sharon Courtney, our excellent Education Officer, who alas has gone on to greater things.

My job would have been impossible these last three years without the wonderful work of Carol O'Dwyer and Jill Greenwood on the Society side, and a range of people too numerous to name, the people who staff the Museum. I have as always greatly welcomed my talks, occasionally over foaming mugs, with Mike Hill, who is going a brilliant job as Director. My thanks - the thanks of the whole Council - to all of them. I approach leaving the job of Chairman with mixed feelings, but in the knowledge that the Museum and the Society are in excellent hands. The year or two's break I propose to take from Council will I hope be a freshener, and there are one or two exciting Brontë projects which will jostle with murder for my attention.

Many thanks to all of you for your interest and support.

NOTES TO THE ACCOUNTS 31 DECEMBER 1998

1. ACCOUNTING POLICIES

Basis of Accounting

The statement of accounts have been prepared in accordance with the provisions of the Companies Act 1985, the Statement of Recommended Practice Accounting by Charities and applicable accounting standards. Where necessary the headings laid down in the Companies Act have been adapted to meet the special activities of the Society. The Society qualifies as a small company under the Companies Act 1985, the trustees have elected to take advantage of the exemption under FRS1 not to prepare a cash flow statement.

Income

Bequests and donations are accounted for when received by the Society. Other income is accounted for on an accruals basis as far as it is prudent to do so. Income includes income tax recoverable.

Grants

Revenue grants are credited to the Statement of Financial Activities as received.

Taxation

As a registered charity, the company benefits from Rates relief and is generally exempt from Income Tax and Capital Gains Tax, but not from VAT.

Investments

Gains and losses whether realised or not are reported in the Statement of Financial Activities. Investment Income has been taken into account on the basis of the date of payment.

Depreciation

Depreciation of tangible fixed assets is provided at the following annual rates in order to write off each asset over its estimated useful life:-

Freehold building	2% on cost
Fixtures, fittings and equipment	15% straight line
Computer equipment	33% straight line

No depreciation is provided on freehold land.

Stocks

Stocks consist of shop merchandise held for resale and are shown at the lower of cost and net realisable value after making due allowance for obsolete and slow moving items.

Pensions

The Society contributes to the personal pension schemes of a number of employees. The cost of the contributions made by the charity to these schemes is charged to profit and loss account as incurred.
