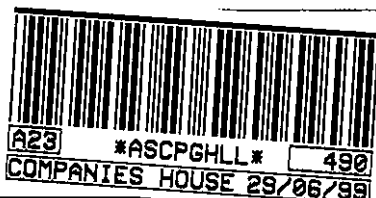

NOTES
