#### Notes to the financial statements

#### 1. Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements

#### Basis of preparation

The financial statements of the company have been prepared under the historical cost convention and in accordance with applicable UK accounting standards. The bases used are consistent with those used in the previous year.

The company is a wholly owned subsidiary of Diageo plc and is included in the consolidated financial statements of Diageo plc which are publicly available. Consequently the company has taken advantage of the exemption from preparing a cash flow statement under the terms of Financial Reporting Standard No. 1 (Revised 1996)

The company is exempt under the terms of Financial Reporting Standard No 8 from disclosing related party transactions (but not balances) with entities that are wholly owned by a member of the Diageo plc group ("group undertakings")

The share capital of the company was reduced by £1,420,637 to £2 and the share premium account was reduced by £763,184 to nil in a meeting of the board of directors held on 14 October 2010 Both reductions were credited to distributable reserves. The board of directors approved a payment of interim dividend of £22,865,744 which is available for distribution once the share capital reduction and the cancellation of the share premium account has become effective

On the same day the board of directors changed the name of the company from Grand Hotels (Mayfair) Limited to Diageo CL2 Limited The change is effective from the date of the certificate of incorporation on change of name given at Companies House on 19 October 2010
