AND the Applicants by their Solicitors undertaking within one month, of the restoration of the name of the Company to the Register of Companies:-



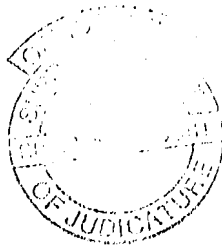
- (1) to procure delivery to the Registrar of Companies in respect of the financial year of the Company determined by reference to its accounting reference period ended the 31st December in each of the years 1985 and 1986 inclusive a copy of every document to be comprised in the accounts of the Company. (Section 239, and for a small or medium sized Company within the meaning of Section 248 Schedule 8 (Part 1), of the Companies Act, 1985).
- (2) to forward to the Registrar of Companies a copy of the annual return of the Company for each of the years 1984 to 1986 inclusive in the prescribed form and signed by both a director and the secretary of the Company (Sections 364 and 365 of the Companies Act, 1985).
- (3) to send to the Registrar of Companies notification in the prescribed form of any change (i) among the directors of the Company or in its Secretary and (ii) in the particulars contained in its register of directors and secretaries and of the date on which each such change occurred (Section 288 of the Companies Act, 1985), and
- (4) to give to the Registrar of Companies notice in the prescribed form of any change in the situation of the registered office of the Company (Section 287 of the Companies Act, 1985) and
- (5) within two months of the restoration of the name of the Company to the Register of Companies to transmit to the Charity Commission at 14 Ryder Street, St. James London, SW1H 6AH statements of account for the years 1971 to 1986 inclusive giving the prescribed information about the affairs of Charity.

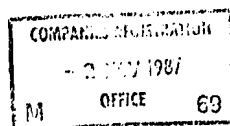

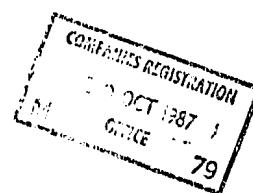
