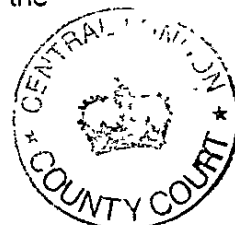
AND upon the Claimant by his Solicitors undertaking to

AND UPON the Claimant and the Registrar of Companies (the Defendant) both acting by their solicitors consenting to this Order

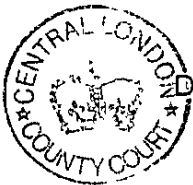
IT IS ORDERED THAT

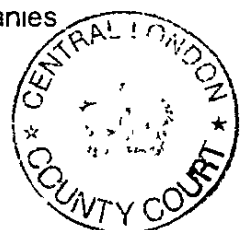
