At an Extraordinary General Meeting of the above-namel Constituted duly convened and held at the Offices of Messrs. Taylor, Noble Company, 1936 Limited, Adelaide House, King William Street, in the City of London, on the 16th day of December, 1936, the following Resolution was duly passed:—

That it is desirable to capitalise the sum of £5,000, being part of the undivided profits of the Company standing to the credit of the General Reserve Account and out of undistributed profits of the Company, and accordingly that a special Capital Bonus of £5,000, free of Income Tax, be declared, and that such Bonus be applied on behalf of the persons who on the date of the passing of this Resolution were Holders of Ordinary Shares of the Company, in payment in full for 50,000 shares of the Company of two shillings each, and that such 50,000 shares of two shillings each, credited as fully-paid, be accordingly distributed to such persons respectively in the proportion of one of such shares for every eight Ordinary Shares held by such persons respectively, and that the shares so distributed shall be treated for all purposes as an increase of the nominal amount of the capital of the Company held by each such Shareholder, and not as income, and that the Directors be authorised to make the appropriate distribution in accordance with Article 122 (a) of the Articles of Association of the Company.


