Notes to the financial statements

1. Accounting policies

a) Statement of compliance

The company is a private United Kingdom company limited by guarantee. It is both incorporated and domiciled in England and Wales (registered number 00096866). The address of its registered office is 16–19 Hurlingham Business Park, Sullivan Road, London, SW6 3DU.

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

b) Basis of preparation

The financial statements have been prepared under the historical cost convention.

The financial statements are prepared in Pounds Sterling (GBP), which is the functional currency of the entity.

c) Financial instruments

Financial assets such as cash and debtors are measured at the present value of the amounts receivable, less an allowance for the expected level of doubtful receivables. Financial liabilities such as trade creditors, loans and finance leases are measured at the present value of the obligation.

d) Going Concern

The financial statements have been prepared on a going concern basis. The directors are continually reviewing future projections at a group level. The directors are satisfied that the group, and therefore the dormant subsidiaries will continue as a going concern for the foreseeable future (at least 12 months from the date of signing of these financial statements).

2. Liability of members

The company does not have a share capital. The company is limited by guarantee and the liability of its 2 members is limited to £10 each.

3. Controlling party

In the opinion of the board, the ultimate controlling party is the Nicholas Freeman Business Trust, constituted under English Law.
