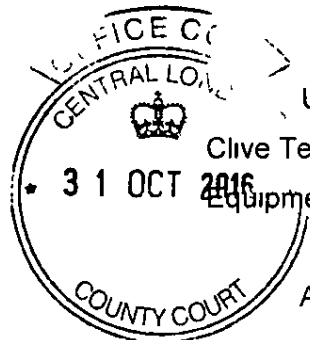

(6) the hearing fixed for the <sup>21 October</sup>~~8 April~~ 2016 at 2 00 pm be vacated


