The Company has an employee retention fund whereby certain amounts owed to employees are held subject to a mortgage to Welcome Nance Group Limited for the exclusive purpose of meeting liabilities to employees in the event that these cannot be paid another way. The liabilities which this relates is listed in this Statement of Affairs. All employees are expected to be paid in full prior to the commencement of the liquidation with the exception of a small number of employees retained into the liquidation.

- 2 These funds are held in trust by the Company for the exclusive purpose of meeting liabilities to current and former customers of the Company arising from the sale of PPI before 14 January 2005. The liability to which this relates is listed in this Statement of Affairs. The trust fund will be topped up to match the estimated liability prior to the commencement of the liquidation.
- 3 The loan book is valued at zero as no further collection or sale activity is expected. All collection activity ceased as from 31 October 2019.
- 4 Existing gross loan balances may be used to set off retail claims in liquidation where appropriate.
- 5 The VAT debtor relates to interest on a VAT refund anticipated to be received from HMRC before the commencement of the liquidation. The gross amount is £0.2 million with £0.1 million due to Cattles Limited (in liquidation).
- 6 Other amounts receivable relate to amounts due under the Scheme from Wilmington Trust and Bovess Holding Limited.
- 7 It is intended to pay all trade creditors in full. Ideally this will occur before the commencement of the liquidation, although it may not be possible to avoid logistical issues such as invoices in transit or any uninvoiced costs, in which case these amounts will be paid after the commencement of the liquidation.
- The value assigned to retail creditors factors in anticipated response and uphold rates. The estimated maximum liability to these creditors is £12.2 million.
- 3 As the Scheme was a "shrink to fit" scheme, the Scheme Creditors receive all available funds after all other claims in liquidation and the liquidation costs have been met in full.


