SUBJECT THERETO AND TO ANY SPECIAL RIGHTS WHICH MAY BE ATTACHED TO ANY OTHER CLASS OF SHARES THE PROFITS OF THE COMPANY AVAILABLE FOR DIVIDEND AND RESOLVED TO BE DISTRIBUTED SHALL BE DISTRIBUTED BY WAY OF DIVIDEND AMONG THE HOLDERS OF THE ORDINARY SHARES IN ACCORDANCE WITH THE CAPITAL PAID UP ON THE ORDINARY SHARES HELD BY THEM RESPECTIVELY. (B) ON A RETURN OF ASSETS IN A WINDING UP OR ON A REDUCTION OF CAPITAL THE ASSETS OF THE COMPANY AVAILABLE FOR DISTRIBUTION AMONG THE MEMBERS SHALL BE APPLIED:- (I) IN REPAYING TO THE HOLDERS OF THE PREFERENCE SHARES THE AMOUNTS PAID UP ON SUCH SHARES TOGETHER WITH (A) WHENEVER THE AVERAGE OF THE RESPECTIVE MEANS OF THE DAILY NOMINAL QUOTATION OF THE PREFERENCE SHARES ON THE STOCK EXCHANGE DURING THE SIX MONTHS PRECEDING THE DATE OF THE NOTICE OF THE MEETING AT WHICH THE RESOLUTION FOR SUCH WINDING UP OR REDUCTION OF CAPITAL IS PASSED EXCEEDS THE NOMINAL AMOUNT PAID UP ON SUCH PREFERENCE SHARES (SUCH AVERAGE TO BE CALCULATED AND CERTIFIED BY THE AUDITORS OF THE COMPANY), A PREMIUM EQUAL TO THE SUM BY WHICH SUCH AVERAGE EXCEEDS THE NOMINAL AMOUNT PAID UP ON SUCH SHARES, AND (B) THE PAYMENT OF ALL ARREARS AND ACCRUALS OF THE SAID FIXED CUMULATIVE PREFERENTIAL DIVIDEND CALCULATED DOWN TO THE REPAYMENT OF CAPITAL (AND IN THE CASE OF A WINDING UP WHETHER EARNED OR DECLARED OR NOT). PER ANNUM ON THE CAPITAL FOR THE TIME BEING PAID UP ON THE PREFERENCE SHARES HELD BY THEM RESPECTIVELY. SUBJECT THERETO AND TO ANY SPECIAL RIGHTS WHICH MAY BE ATTACHED TO ANY OTHER CLASS OF SHARES THE PROFITS OF THE COMPANY AVAILABLE FOR DIVIDEND AND RESOLVED TO BE DISTRIBUTED SHALL BE DISTRIBUTED BY WAY OF DIVIDEND AMONG THE HOLDERS OF THE ORDINARY SHARES IN ACCORDANCE WITH THE CAPITAL PAID UP ON THE ORDINARY SHARES HELD BY THEM RESPECTIVELY.
