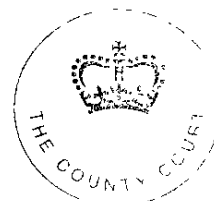

IT IS ORDERED THAT:

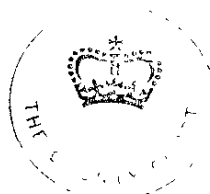


- (1) the name of the above named United Baltic Corporation Limited be restored to the Register of Companies

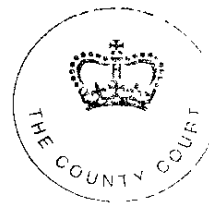
