**ORDER**

---

**UPON THE ORDINARY APPLICATION** of the Administrators ("**the Administrators**") of the companies ("**the Companies**") listed in Schedules 1 and 2 to this order

**AND UPON HEARING** Leading Counsel for the Administrators and Leading Counsel for Federal-Mogul Corporation ("**FMC**") and the Companies

**AND UPON FMC** undertaking by its Counsel in the following terms:

- (1) In the case of Federal-Mogul Camshaft Castings Limited ("**FMCC**") that within 3 months of the date of the discharge of the administration order made in respect of FMCC, it shall take such steps as are necessary to restore, or to procure that any of the other companies within the Federal-Mogul group which are presently the subject of proceedings under Chapter 11 of the US Bankruptcy Code ("**the Debtors**") restore, FMCC to solvency (taking into account, in determining FMCC's solvency, only its assets and liabilities as are set out in the Administrators' Statement of Affairs and Liquidation Statement exhibited at Tab 6 page 5 of the exhibit to James John Gleave's 25<sup>th</sup> witness statement dated 13 November 2006 marked "JJG 25" and the steps that have been taken in this regard) and that FMC, within one month of such action being taken, shall lodge with the Court a statement made by its General

Counsel or one of its other officers giving details of the steps that have been taken in this regard.

- (2) In the case of Federal-Mogul Camshafts Limited ("**FMCL**") that as soon as practicable after the date of the discharge of the administration order made in respect of FMCL, it shall, and shall procure that any other Debtor shall, take such steps as are necessary to obtain appropriate approvals in its Chapter 11 proceedings to permit FMC to issue to the High Court of Justice in England an undertaking in the terms set out below, and within one month of such approvals having been given shall lodge with the Court a statement made by its General Counsel or one of its other officers confirming that the undertaking has taken effect.

"That within 3 months of the date of the discharge of the administration order made in respect of Federal-Mogul Camshafts Limited ("**FMCL**"), or, if later, within one month of such approvals having been given, it shall take such steps as are necessary to restore, or to procure that any other Debtor restore, FMCL to solvency (taking into account, in determining FMCL's solvency, only its assets and liabilities as are set out in the Administrators' Statement of Affairs and Liquidation Statement at Tab 6, page 6 of JJG 25 and the steps that have been taken in this regard) and that FMC, within one month of taking such action, shall lodge with the Court a statement made by its General Counsel or one of its other officers giving details of the steps that have been taken in this regard."

- (3) In the cases of AE Group Machines Limited, Federal-Mogul Eurofriction Limited, Federal-Mogul Ignition (UK) Limited, Federal-Mogul Sealing Systems (Rochdale) Limited, Federal-Mogul Systems Protection Group Limited, Federal-Mogul Technology Limited, Ferodo Limited, G.B. Tools & Components Exports Limited, J.W. Roberts Limited, Lanoth Limited, and TAF International Limited, that before any such Company commences, or recommences any trading activities, including in particular incurring any liabilities to any third party in connection with such trading, that FMC shall take such steps as are necessary to restore, or to procure that any other

Debtor restore, such Company to solvency (taking into account, in determining such Company's solvency, only its assets and liabilities as are set out in that Company's Solvency Statement and the steps that have been taken in this regard) and that FMC, within one month of taking such action, shall lodge with the Court a statement made by its General Counsel or one of its other officers giving details of the steps that have been taken in this regard. For these purposes, the Companies' **Solvency Statements** are the statements set out in JJG 25 or the exhibit to the witness statement of David Anthony Bozynski dated 13 November 2006 marked "DAB1", as follows: (a) for AE Group Machines Limited, at page 35 of DAB1; (b) for Federal-Mogul Eurofriction Limited, at Tab 6, page 8, of JJG 25; (c) for Federal-Mogul Ignition (UK) Limited, at Tab 6, page 10, of JJG 25; (d) for Federal-Mogul Sealing Systems (Rochdale) Limited, at Tab 6, page 13, of JJG 25; (e) for Federal-Mogul Systems Protection Group Limited, at Tab 6, page 18, of JJG 25; (f) for Federal-Mogul Technology Limited, at Tab 6, page 19, of JJG 25; (g) for Ferodo Limited, at page 15 of DAB1; (h) for G.B. Tools & Components Exports Limited, at page 41 of DAB1; (i) for J.W. Roberts Limited, at page 19 of DAB1; (j) for Lanoth Limited, at page 20 of DAB1; and (k) for TAF International Limited, at page 26 of DAB1.

RELATING TO THIS APPLICATION

AND UPON READING the evidence ~~recorded on the court file as having been read~~

IT IS ORDERED that:

- 1 Pursuant to section 18(3) of the Insolvency Act 1986 and subject to paragraph 3 below, the administration order applicable to each of the Companies listed in Schedule 1 to this order be discharged with effect from 1 December 2006.
- 2 The application for the discharge of the administration order applicable to each of the Companies listed in Schedule 2 to this order be adjourned generally with permission to restore.
- 3 Pursuant to section 18(3) of the Insolvency Act 1986, the Administrators shall retain in relation to each of the Companies listed in Schedule 1 all necessary powers under the Insolvency Act 1986 and the Insolvency Rules 1986 so as to enable them to have their remuneration fixed by the relevant creditors

committee, by a meeting of creditors, and/or by the court pursuant to Insolvency Rules 2.47, 2.48, and 2.49 notwithstanding the discharge of the administration orders.

- 4 Pursuant to section 20(1)(b) of the Insolvency Act 1986, the Administrators shall have their release in respect of each Company listed in Schedule 1 14 days after complying with their obligations under Insolvency Rule 2.52 in respect of the relevant Company.
- 5 There be permission to apply on or before 30 November 2006.
