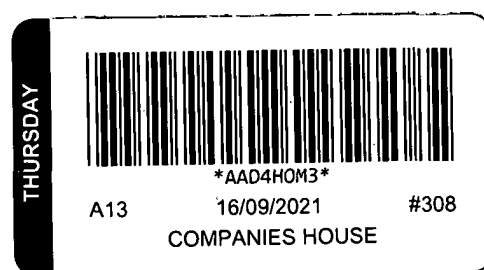

Balance sheet as at 31 December 2020

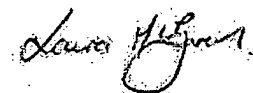
