# FORM 155(6)b - RIDER C

The principal terms on which the assistance will be given are:-

- (i) under the Guarantee, the Subsidiary unconditionally guarantees the payment or discharge of the Secured Liabilities owing by the Subsidiary and each of the other members of the Group which has granted or will grant security in favour of the Bank;
- (ii) under the Debenture, the Subsidiary charges by way of legal mortgage, fixed and floating charges, the whole of its property (including uncalled capital) undertaking and assets in favour of the Bank to secure the Secured Liabilities; and
- (iii) the Subsidiary agrees in terms of the Funding Agreement, subject to the satisfaction of certain conditions, to lend funds to the Purchaser on the terms set out therein in order to enable the Purchaser *inter alia* to discharge its obligations under the Facility Letter and to make certain other payments.

Where:-

"Facility Letter"

means the facility letter dated on or around the date hereof (as amended, restated, novated or supplemented from time to time) between the Purchaser and the Bank:

"Group"

means the Purchaser and each of its subsidiaries from time to time;

"Secured Liabilities"

means all or any monies and liabilities which will for the time being (and whether on or at any time after demand) be due, owing or incurred in whatsoever manner to the Bank by the Subsidiary, whether actually or contingently, solely or jointly and whether as principal or surety and whether or not the Bank shall have been an original party to the relevant transaction, and including interest, discount, commission and other lawful charges or expenses which the Bank may in the course of its business charge or incur in respect of any of those matters or for

keeping the Subsidiary's account and so that interest shall be computed and compounded according to the usual rates and practice of the Bank;

and any term defined in Rider B shall have the same meaning in this Rider C.
