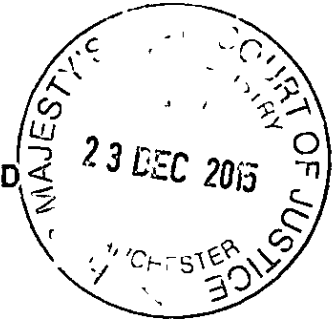

IT IS ORDERED that:


- (1) the name of the above Pifco Distribution Limited be restored to the Register of Companies

of the said Application in the agreed sum of £300-00


