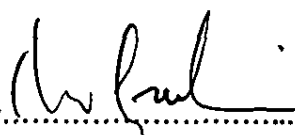
For the year ended 31<sup>st</sup> December 2012 the company was entitled to exemption under section 480 of the Companies Act 2006.

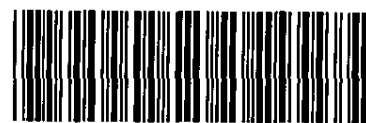
