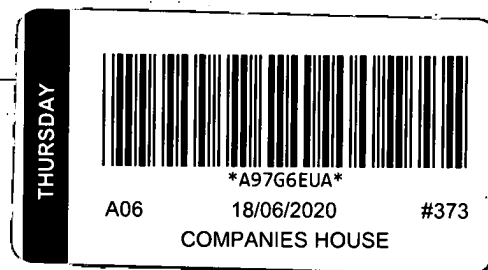



INTRODUCTION

Widewarm Head Systems Limited (Entity) entered members' voluntary liquidation on 28 June 2019. Emma Cray and David Matthew Hammond were appointed joint liquidators of the Entity (Liquidators).

This account covers the conduct and progress of the liquidation in the period from 28 June 2019 to 18 June 2020 (Period). This is the Liquidators' final account of the liquidation.

A summary of receipts and payments in the liquidation including for this Period is at Appendix A.

The statutory information relating to the Entity and the Liquidators is at Appendix B.

REPORT ON THE LIQUIDATION

Realisation of assets:

There were no assets identified within the directors' Declaration of Solvency.

The Liquidators have not identified any additional assets of the Entity and are not aware of any other assets that remain to be realised.

Settlement of liabilities:

The directors' Declaration of Solvency showed that the Entity had no liabilities.

In the Period, the Liquidators published a notice in the London Gazette inviting creditors to submit details of claims they may have against the Entity.

The Liquidators have not received any claims in the liquidation.

HM Revenue & Customs ("HMRC"):

Following their appointment, the Liquidators wrote to HMRC to inform them of the liquidation and to request details of any outstanding liabilities. HMRC have confirmed that the Entity has no outstanding tax liabilities and that they have no objection to the liquidation being closed.

Distributions to Members:

As there were no assets to distribute. However, a distribution in specie comprising of any other assets was made to the Member of the Entity on 10 May 2020. A notional value of £1 was attributed to the distribution to cover any other assets of the Entity.

Basis of remuneration

Liquidators' remuneration

As there were no funds in the estate, the Entity's Member, CRH (UK) Ltd, agreed to settle all costs associated with the liquidation of the Entity and 11 other connected entities.

The Liquidators have been paid £27,915 in the Period in respect of the Entity and 11 connected entities.

Liquidators' expenses¹

The Liquidators have incurred the following expenses in connection with the liquidation of the Entity and 11 connected entities. CRH (UK) Ltd has settled such expenses plus VAT.

Members' rights regarding the Liquidators' remuneration and expenses

Any member of the Entity with permission of the court or members of the Entity with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the entity (or permission of the court) are entitled to request further information about our fees and expenses. Such requests need to be made within 21 days of receipt of this report. See Rule 18.9 of the Insolvency (England and Wales) Rules 2016 for further detail.

Any member of the Entity with permission of the court or members of the Entity with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the entity (or permission of the court) are entitled to claim by way of court application that the liquidators' fees and expenses are excessive. Such applications need to be made within 8 weeks of the receipt of this report. See Rule 18.34 of the Insolvency (England and Wales) Rules 2016 for further detail.
