(i) That by 30 June 2016, the current Administrators file an application to court, seeking the appointment of Geoffrey Paul Rowley and Anthony John Wright of FRP Advisory LLP, 110 Cannon Street, London, EC4N 6EU as additional joint Administrators, with a view to the application being heard by 29 July 2016. This is in order to commence additional investigatory work into the Company's affairs, with the current Administrators remaining in office to conclude trading activities and asset realisations ahead of a Creditors Voluntary Liquidation.

It is further proposed that Geoffrey Paul Rowley and Anthony John Wright of FRP Advisory LLP, 110 Cannon Street, London, EC4N 6EU be appointed Joint Liquidators of the company and, that where Joint Liquidators are appointed, any act required or authorised to be done by the Joint Liquidators may be exercised by both or either of them

- (ii) That the current joint Administrators are not discharged from all liability pursuant to Paragraph 98 of Schedule B1 to the Insolvency Act 1986 upon—filing the end of the Administration or their appointment otherwise ceasing
- (iii) That the current Joint Administrators' time costs are reduced by 15% in relation to Administration & Planning work incurred to date and by 15% (based on their current regional charge-out rates) for all ongoing work undertaken from 23 June though to

the end of the Administration These are to be drawn with the prior approval of the majority of voting creditors by value. The time costs of DLA are to be reduced by 10% from the commencement of Administration through to the end of the Administration.
