CHAIR'S REPORT

IN THE HIGH COURT OF JUSTICE CR-2019-003530 BUSINESS AND PROPERTY COURTS OF ENGLAND AND WALES INSOLVENCY AND COMPANIES LIST

COMPANY VOLUNTARY ARRANGEMENT under Part I of the Insolvency Act 1986 (as amended)

CHAIR'S REPORT OF CONSIDERATION OF PROPOSAL UNDER SECTIONS 4(6) AND 4(6A) OF THE INSOLVENCY ACT 1986 (AS AMENDED) ("ACT") AND RULE 2.38 OF THE INSOLVENCY (ENGLAND AND WALES) RULES 2016 ("RULES")

This is the report of Daniel Francis Butters of Deloitte LLP, 1 New Street Square, London EC4A 3HQ ("Chair") made pursuant to Sections 4(6) and 4(6A) of the Act and Rule 2.38 of the Rules, on the result of the consideration by the creditors and the member of Arcadia Group Limited (company number 00237511) ("Company"), of the proposal ("Proposal") for a Company Voluntary Arrangement ("CVA") (made by the directors ("Directors") of the Company) under Part I of the Act in respect of the Company.

Creditors' Decision Procedure

- Following a written request from the prescribed minimum number (as defined in section 246ZE(7) of the Act) of the Company's creditors, a physical meeting of the Company's creditors ("Creditors' Meeting") was summoned in accordance with Rules 2.31, 15.6 and 15.8 of the Rules and Section 246ZE of the Act, and was convened to be held at etc. Venues, County Hall, Riverside Building, Belvedere Road, London SE1 7PB on 5 June 2019 at 12 noon. The Chair summoned the Creditors' Meeting pursuant to Section 3 of the Act.
- 2. At the Creditors' Meeting, the Chair explained that the legislation which deals with company voluntary arrangements is contained in Part I of the Act.
- 3. The Chair advised those present at the meeting that as nominee, pursuant to Rule 2.34 of the Rules, he was Chair.
- 4. The Chair explained that the Creditors' Meeting was being held concurrently with creditors' meetings proposed by other companies in the Arcadia group ("Group") (being the companies ("Other Companies") listed at schedule 3) ("Other Creditors' Meetings") and that this was being done in the interests of efficiency and practicality.
- 5. The Chair asked whether there was any objection to the notice of meeting and the Proposal, as dispatched to creditors and the member on 22 May 2019, being taken as read and there were no objections.
- 6. The Chair informed the creditors that a letter prepared by the joint nominees dated 24 May 2019 appending various drafting clarifications in relation to the Proposal had been placed on the web portal on 24 May 2019 for the attention of all creditors of the Company ("**Drafting Clarification Letter**"). The Chair asked whether there were any objections to the drafting clarifications set out in the Drafting Clarification Letter being taken as read and there were none.

- 7. The Chair informed the creditors that a letter dated 31 May 2019 appending certain clarifications and modifications in relation to the Proposal had been prepared by the joint nominees and acknowledged by the Directors and the Company ("First Clarification and Modification Letter"). The Chair noted that the First Clarification and Modification Letter had been placed on the web portal on 31 May 2019 for the attention of all creditors of the Company. The Chair asked whether there were any objections to the proposed clarifications and modifications set out in the First Clarification and Modification Letter being taken as read and there were none.
- 8. The Chair noted that the terms of the Proposal (as dispatched to creditors and the member on 22 May 2019) had been made conditional on:
 - a. the maturity date of a secured £310 million facility agreement (originally dated 20 June 2014 (as amended or amended and restated from time to time) and made between (amongst others) Taveta Investments (No. 2) Limited; Redcastle (214 Oxford Street) Limited and The Royal Bank of Scotland plc) being formally extended to December 2019 ("Facility Extension Condition"); and
 - b. a formal arrangement being made with the UK Pension Scheme Trustees that would achieve a significant reduction in the level of deficit repair contributions payable by the Company to the UK Pension Schemes ("Pension Condition").
- 9. The Chair reported that the Facility Extension Condition and the Pension Condition had been satisfied prior to the Creditors' Meeting.
- 10. The Chair informed the creditors that a letter dated 4 June 2019 ("Conditions and Clarification Letter") had been placed on the web portal on 5 June 2019 for the attention of all creditors of the Company, which provided clarification and an update in relation to satisfaction of the Facility Extension Condition and the Pension Condition. The Conditions and Clarification Letter was read out in its entirety to those present at the meeting. No objections were raised.
- 11. Modifications to the Proposal were then proposed by a creditor ("**Creditor Modifications**"). As a result, the Chair suspended the meeting for a period of 30 minutes to enable the modifications to be considered by the Directors and the Company. On resumption of the meeting the Chair confirmed that the Directors and the Company had accepted the modifications. The Creditor Modifications were read out in their entirety to those present at the meeting.
- 12. Modifications and clarifications to the Proposal were also proposed by the Directors extending the landlord breaks for category B1 and B2 landlords for all CVA proposals with category B landlords ("Company Modifications"). The Company Modifications were read out in their entirety to those present at the meeting.
- 13. The following decision was proposed to the Company's creditors to be decided either 'for' or 'against':

"For the acceptance of the proposed voluntary arrangement as circulated, with the proposed modifications"

- 14. It was noted that the proposed modifications were the clarifications and modifications set out in the Drafting Clarification Letter; the First Clarification and Modification Letter; the Conditions and Clarification Letter; the Creditor Modifications; and the Company Modifications.
- 15. Pursuant to Section 3 of the Act, the Company's creditors were asked to make a decision on the above.
- 16. Following the commencement of voting in relation to the above decision, the Creditors' Meeting was adjourned by the Chair in accordance with Rule 15.23 of the Rules to enable further discussions and enquiries with landlords with a view to garnering sufficient support for the CVA (and the CVAs of the Other Companies). The Chair explained that this decision was made in the context of the supportive stance taken by the UK Pension Trustees, the Pensions Regulator, the Pension Protection Fund, trade creditors and a significant number of landlords and, in practical terms and in order to ensure the viability

- of the group going forward, it was desirable that all seven CVAs passed. The Creditors' Meeting was adjourned to 12 June 2019 at 12 noon.
- 17. A letter prepared by the joint nominees appending the Creditor Modifications and the Company Modifications was placed on the web portal on 7 June 2019 for the attention of all creditors of the Company.
- 18. The Creditors' Meeting was resumed at 12 noon on 12 June 2019 at etc. Venues St Paul's, 200 Aldersgate, St Pauls, London EC1A 4HD.
- 19. The Chair informed the Company's creditors that a letter dated 9 June 2019 clarifying and modifying certain matters in relation to the Proposal had been prepared by the joint nominees and acknowledged by the Directors and the Company ("Second Clarification and Modification Letter"). The Chair noted that the Second Clarification and Modification Letter had been placed on the web portal on 9 June 2019 for the attention of all creditors of the Company. The Chair asked whether there were any objections to the proposed clarifications and modifications set out in the Second Clarification and Modification Letter being taken as read and there were none.
- 20. The Chair informed the Company's creditors that there was a further clarification in respect of the Proposal ("**Third Clarification**"). The Third Clarification was read out in its entirety to those present at the meeting.
- 21. The following decision ("**Creditors' Decision**") was proposed to the Company's creditors to be decided either 'for' or 'against':

"For the acceptance of the proposed voluntary arrangement as circulated, with the proposed modifications"

- 22. It was noted that the proposed modifications in respect of the Creditors' Decision were the clarifications and modifications set out in the Drafting Clarification Letter; the First Clarification and Modification Letter; the Conditions and Clarification Letter; the Creditor Modifications; the Company Modifications; the Second Clarification and Modification Letter; and the Third Clarification.
- 23. Pursuant to Section 3 of the Act, the Company's creditors were asked to make a decision on the Creditors' Decision.
- 24. Set out in Schedule 1 to this report is a list of the Company's creditors (with their respective values) who were present or represented at the meeting, showing how they voted on the Creditors' Decision.
- 25. In accordance with Rule 15.34 of the Rules, a decision is made when three quarters or more (in value) of creditors responding on the decision vote in favour of it. However, the decision will not be approved if more than half of the total value of the creditors voting on the decision who are considered by the Chair to be unconnected to the Company vote against them.
- 26. In addition, the terms of the Proposal (as modified) provide that the Proposal shall not become effective if more than half of the total value of the creditors voting on the decision who are considered by the Chair to be unconnected to the Company (excluding the UK Pension Scheme Trustees, whose vote is exercised by the Pension Protection Fund in accordance with section 137 of the Pensions Act 2004) vote against it.
- 27. The Creditors' Decision was duly passed. The Proposal as modified in the Drafting Clarification Letter; the First Clarification and Modification Letter; the Conditions and Clarification Letter; the Creditor Modifications; the Company Modifications; the Second Clarification and Modification Letter; and the Third Clarification was approved by the Company's creditors (without further modification).

Meeting of the Company

- 28. Pursuant to section 3 of the Act, the meeting of the Company was convened to be held at Colegrave House, 70 Berners Street, London W1T 3NL on 6 June 2019 at 8:30am ("Member's Meeting").
- 29. At the Member's Meeting, the Chair explained that the legislation which deals with company voluntary arrangements is contained in Part I of the Act.
- 30. The Chair advised those present at the meeting that as nominee, pursuant to Rule 2.34 of the Rules, he was Chair.
- 31. The Chair explained that the Member's Meeting was being held concurrently with member's meetings proposed by the Other Companies and that this was being done in the interests of efficiency and practicality.
- 32. The Chair noted that in accordance with Rule 2.28 of the Rules, the Company's creditors must consider and decide whether to approve the Proposal before the member can consider and decide whether to approve the Proposal.
- 33. The Chair reported to the meeting that the Creditors' Meeting had been opened at 12 noon on 5 June 2019, but that it had been adjourned by the chair of the Creditors' Meeting pursuant to Rule 15.23 of the Rules. The Chair noted that in view of the adjournment of the Creditors' Meeting and Rule 2.28 of the Rules, the decision of the member on whether to approve the Proposal would need to be delayed.
- 34. The Chair adjourned the Member's Meeting to 9:00am on 13 June 2019 at Deloitte LLP, 1 New Street Square, London EC4A 3HQ.
- 35. The Member's Meeting was resumed at 9:00am on 13 June 2019 at Deloitte LLP, 1 New Street Square, London EC4A 3HQ.
- 36. The Chair asked whether there was any objection to the notice of meeting and the Proposal, as dispatched to the Company's creditors and the member on 22 May 2019, being taken as read and there were no objections.
- 37. The Chair noted the clarifications and modifications to the Proposal set out in the Drafting Clarification Letter; the First Clarification and Modification Letter; the Conditions and Clarification Letter; the Creditor Modifications; the Company Modifications; the Second Clarification and Modification Letter; and the Third Clarification, which had been approved by the Company's creditors at the Creditors' Meeting. No modifications were proposed by the member of the Company.
- 38. The following resolution ("Member's Resolution") was proposed to the Company's member to be decided either 'for' or 'against':

"For the acceptance of the proposed voluntary arrangement as circulated, with the proposed modifications"

- 39. It was noted that the proposed modifications in respect of the Member's Resolution were the clarifications and modifications set out in the Drafting Clarification Letter; the First Clarification and Modification Letter; the Conditions and Clarification Letter; the Creditor Modifications; the Company Modifications; the Second Clarification and Modification Letter; and the Third Clarification.
- 40. A vote was taken on the Member's Resolution. Set out in Schedule 2 to this report are details of the Company's member (showing the value of its shareholding) who was present or represented at the Member's Meeting, showing how it voted on the Member's Resolution.
- 41. It was noted that the Member's Resolution was to be regarded as passed when a majority in value of those voting have voted in favour of it, subject to any express provision to the contrary in the articles of association of the Company. Having regard to the provisions of Rule 2.36 of the Rules, the Chair declared the Member's Resolution duly passed.

42. The Proposal as modified in the Drafting Clarification Letter; the First Clarification and Modification Letter; the Conditions and Clarification Letter; the Creditor Modifications; the Company Modifications; the Second Clarification and Modification Letter; and the Third Clarification was approved by the Company's member (without further modification).

EU Regulation on Insolvency Proceedings

In the opinion of the joint supervisors, the Regulation (EU) 2015/848 of the European Parliament and of the Council of 20 May 2015 on insolvency proceedings (recast), applies to the company voluntary arrangement and these proceedings are main proceedings as defined by Article 3 of that regulation.
