Property charged pursuant to a Legal Charge in favour of Nationwide dated 8th July 2003

The Company with full title guarantee charges to Nationwide:

- 1. By way of legal mortgage the freehold property known as Unit 7a East Park Trading Estate, Gordon Road, Bristol, BS5 7DR (title number AV 101038) (the "Property") and all buildings, assets of whatsoever nature, apart from land and buildings ("Fixtures") (including trade Fixtures) and fixed plant and machinery from time to time on such property together with all estates, rights, title options, easements and privileges appurtenant to, or benefiting, the same including all beneficial interests and Rights of the Company in the Property and in any proceeds of sale or disposal of any part of the Property.
