#### REPORT OF THE AUDITORS TO THE MEMBERS OF

#### WIGAN ATHLETIC A.F.C. LIMITED

We have audited the Annexed Accounts in accordance with approved auditing standards having regard to the matters referred to in the following paragraphs.

Where independent confirmation of the completeness of the accounting records was not available, we have accepted assurances from the directors that all of the company's transactions have been reflected in the records.

The financial statements have also been prepared under the going concen basis on the assumption that the financial support afforded to the company by its bankers, creditors and directors will continue.

Subject to the above, in our opinion the foregoing accounts, which have been prepared under the Historical Cost Convention as modified by the revaluation of certain of the fixed assets, give a true and fair view of the state of affairs of the company as at 30th April, 1985, and of the loss for the year ended on that date and comply with the Companies Act 1985.
