3. "The remuneration of the Liquidator be fixed at £2,000 plus VAT and disbursements based on the information provided by the members on winding up. Such fee to be re-negotiated with the Members should any other matters arise which had not previously been disclosed, and if existing matters should become protracted. The payment to the liquidator of the following category 2 disbursements in accordance with SIP 9 regulations are agreed :-

Photocopying 18p per copy, mileage at 45/60p per mile, storage of boxes internally £10 per year, £10 for destruction. Room hire for meetings £75. Files and indexes at cost. The above charges are subject to inflationary increases. Other costs e.g. advertising, external storage, are charged as incurred (Ordinary Resolution)

4. The Liquidator be authorised :- (Special Resolution)
 - a. "Under the provisions of Section 165 of the Insolvency Act 1986 to exercise any of the powers laid down by Part 1 of Schedule 4 of that Act as may be necessary or desirable in his judgement, and"
 - b. "In accordance with the Articles of Association of the Company, to divide all or such part of the surplus assets of the Company, as he shall see fit, in specie, amongst the members of the Company."
