 - (b) by way of fixed charge charges in favour of the Security Agent all that property in Northern Ireland (comprised in the folios and more particularly set out in Schedule A to this Companies Form 395 (which if leasehold is a Certificated Property) and any other freehold or leasehold property (which if leasehold is a Certificated Property) together in all cases (to the extent the same are not otherwise subject to a fixed charge hereunder) with all Fixtures and fittings (including trade fixtures and fittings) and

fixed plant and machinery from time to time therein or thereon and the proceeds of sale of all or any part thereof with the payment to the Security Agent of all monies due or to become due by the Company to the Security Agent and hereby consents to the charge created by the Debenture being registered as a burden on such property subject to the proviso for redemption contained at Clause 22 (Release) of the Debenture subject, in the case of any leasehold properties, to any necessary third party's consent being obtained;

- (d) charges to the Security Agent the proceeds of sale of all or any part of the lands mortgaged or charged as referred to in paragraphs (a), (b) and (c) above and the benefit of all estates or interests in any freehold or leasehold property belonging to it; and
- (e) declares that it shall henceforth stand possessed of any reversion vested in it in respect of any of the said freehold and leasehold property which is situate in Northern Ireland (and the title to which is not registered at the Land Registry of Northern Ireland) in trust for the Security Agent and to be conveyed, assigned or otherwise dealt with whether to the Security Agent or its nominee or otherwise as the Security Agent shall direct but subject to the same equity of redemption as may for the time being be subsisting therein AND FURTHER by the Debenture attorns tenant of the Security Agent in respect of each such property,

PROVIDED THAT if, in relation to any leasehold property in Northern Ireland specified in Schedule A to this Companies Form 395 the Company is prohibited, either absolutely or conditionally under the terms and conditions of that leasehold property from creating mortgages or charges in relation to that leasehold property (including, without limitation the condition that consent of a third party is obtained), then a first legal mortgage and first fixed charge shall not affect such leasehold land unless and until, in the case of an absolute prohibition, the prohibition is waived or, in the case of a conditional prohibition, the necessary consent of the landlord is obtained (and where the leasehold property is Certificated Property the Company shall use all reasonable endeavours to obtaining such waiver or consent as soon as possible). 4. (a) Pursuant to the terms of the Debenture to which the Company acceded pursuant to the Deed, the Company with full title guarantee and as security for the payment of all of the Secured Liabilities, charges in favour of the Security Agent by way of a first floating charge all its undertaking and assets both present and future (including, without limitation, any undertaking and assets situated in Scotland (whether or not the same may be mortgaged or charged by way of standard security)), subject always to

all mortgages, fixed charges and assignments created by or pursuant to Clause 2 (Fixed Security), Clause 4 (Assignments) or any other provision of the Debenture.

- (b) In the Debenture to which the Company acceded pursuant to the Deed the Company undertakes to each Lender that, save as expressly permitted under the terms of the Debenture, the Senior Credit Agreement (including without limitation Clause 23.5 (Negative Pledge) and 23.6 (Disposals)) and the Mezzanine Credit Agreement (including without limitation Clause 19.5 (Negative Pledge) and 19.6 (Disposals)) it will not:
 - (i) create or permit to subsist any Security Interest over all or any of the Security Assets other than pursuant to the Debenture or any other Security Document; or
 - (ii) dispose of or agree to dispose of or deal in all or any part of the Security Assets or any interest therein.
- Pursuant to the terms of the Debenture to which the Company acceded pursuant to the Deed, the Company with full title guarantee, as continuing security for the payment, discharge and performance of the Secured Liabilities, assigns and agrees to assign to the Security Agent (as agent and trustee for itself and each of the Lenders) all its right, title and interest (if any) in and to:
 - (i) the Hedging Documents;
 - (ii) the Acquisition Agreements;
 - (iii) the Insurances; and
 - (iv) the Intercompany Documents.

- (a) Slaughter & May in respect of the Main Properties situated in England and Wales;
- (b) McGrigor Donald in respect of the Main Properties situated in Scotland; and
- (c) Arthur Cox in respect of the Main Properties situated in Northern Ireland.

"Chargor" means the companies listed in Schedule D and each company which becomes a party to the Debenture by executing a Deed of Accession;

"Closing" means the date on which the Acquisition is completed under the Acquisition Agreements;

"Co-Lead Arrangers" means each of Lehman Brothers International (Europe), The Royal Bank of Scotland plc and The Governor and Company of the Bank of Scotland;

"Co-ordinator" means J.P. Morgan Securities Ltd. as co-ordinator;

"Declared Default" means an Event of Default which has resulted in the Facility Agent serving a notice under Clause 24.18(a) or (c) of the Senior Credit Agreement and/or an Event of Default which has resulted in the Mezzanine Agent serving notice under any provision of Clause 20.18(a) or (c) of the Mezzanine Credit Agreement (as the case may be);

"Deed of Accession" means a deed substantially in the form of Schedule 8 to the Debenture executed, or to be executed, by a Chargor;
