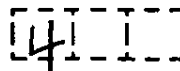

SHORT PARTICULARS OF ALL THE PROPERTY MORTGAGED OR CHARGED

1. CREATION OF SECURITY

1.1 General

- (a) All the security created under the Deed:
- (i) is created in favour of the Security Trustee;
 - (ii) in respect of the floating charge referred to in Clause 1.3 of this Form 395 and clause 2.5 (Floating charge) of the Deed, is created over present and future assets of the Chargor;
 - (iii) is security for the payment of all the Secured Liabilities; and
 - (iv) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994.
- (b) If the rights of the Chargor under a document cannot be secured without the consent of a party to that document:
- (i) the Chargor must notify the Security Trustee promptly;
 - (ii) the Security created under the Deed will secure all amounts which the Chargor may receive, or has received, under that document but exclude the document itself; and
 - (iii) unless the Security Trustee otherwise requires, the Chargor must use reasonable endeavours to obtain the consent of the relevant party to that document being secured under the Deed.
- (c) The Security Trustee holds the benefit of the Deed on trust for the Finance Parties.

1.2 Intellectual property

The Chargor charges, by way of a first fixed charge, all of its rights in respect of Key Brand IPR specified under its name in Schedule 2 to this Form 395.

1.3 Floating charge

- (a) The Chargor charges by way of a first floating charge all its assets not at any time otherwise effectively mortgaged, charged or assigned by way of fixed mortgage, charge or assignment under the Deed.
- (b) Except as provided below, the Security Trustee may by notice to the Chargor convert the floating charge created by the Chargor under this Subclause into a fixed charge as regards any of the Chargor's assets specified in that notice, if:
- (i) the Facility Agent has issued a Repayment Notice to the Parent in accordance with clause 7.1 (b) of the Credit Agreement; or
 - (ii) the Security Trustee considers those assets to be in danger of being seized or sold under any form of distress, attachment, execution or other legal process or to be otherwise in jeopardy, provided that the assets the subject of the legal process have a market value of not less than £7,500,000 or its equivalent.

- (c) The floating charge created by this Subclause may not be converted into a fixed charge solely by reason of:
- (i) the obtaining of a moratorium; or
 - (ii) anything done with a view to obtaining a moratorium,
- under section 1A of the Insolvency Act 1986.
- (d) The floating charge created by this Subclause will automatically convert into a fixed charge over all of the Chargor's assets if (i) an administrator is appointed or the Security Trustee receives notice of an intention to appoint an administrator or (ii) there is a breach by any Obligor of any of its material obligations under the Finance Documents or a representation or warranty made or deemed to be made by any Obligor in any Finance Document or in any document delivered by or on behalf of any Obligor under any Finance Document is incorrect or misleading in any material respect.
- (e) The floating charge created by this Subclause is a **qualifying floating charge** for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act 1986.

2. LIMITATIONS

While any amounts are or may become outstanding under the 2006 Finance Documents:

- (a) the aggregate amount payable to the Finance Parties by the Deed Chargors collectively in respect of each Deed Chargor's obligations in its capacity as a Guarantor, shall not exceed the higher of:
- (i) £15,000,000; and
 - (ii) any higher amount which, if the subject of security guaranteed by the Obligors, would not result in a breach of the 2006 Finance Documents; and
- (b) the aggregate amount payable by the Deed Chargors collectively under the Deed shall not exceed the higher of:
- (i) £75,000,000; and
 - (ii) any higher amount which, if the subject of security guaranteed by the Obligors, would not result in a breach of the 2006 Finance Documents.

3. RESTRICTIONS ON DEALINGS

The Chargor may not:

- (a) create or permit to subsist any Security on any Security Asset or any third party interest on or in the Disposals Account and the debt represented by it; or
- (b) sell, transfer, licence, lease or otherwise dispose of any Security Asset,

except:

- (i) as expressly allowed under the Credit Agreement;
- (ii) in respect of any Security Asset other than a Mortgaged Property, a Key Brand IPR or the Disposals Account, as permitted under the 2006 Facility Agreement; and

- (iii) licences relating to the Key Brand IPR granted in the ordinary course of business or non-use, non-renewal or abandonment of any Key Brand IPR provided that such non-use, non-renewal or abandonment, either alone or together with any other non-use, non-renewal or abandonment of any Key Brand IPR, does not materially adversely effect the value of any Key Brand.

Arranger means Barclays Capital, the investment banking division of Barclays Bank PLC, Lloyds TSB Bank plc and The Royal Bank of Scotland plc as mandated lead arrangers and bookrunners;

B Facility means the revolving loan facility made available under the Credit Agreement as described and defined in paragraph (b) of clause 2.1 (The Facilities) of the Credit Agreement;

B Facility Limit means:

- (a) in relation to each Original Lender, the amount set opposite its name under the heading "B Facility Limit" in Part 2 (The Original Lenders) of Schedule 1 (The Original Parties) to the Credit Agreement and the amount of any other B Facility Limit transferred to it under the Credit Agreement; and
- (b) in relation to any other Lender, the amount of any B Facility Limit transferred to it under the Credit Agreement,

in each case to the extent not cancelled, reduced or transferred by it under the Credit Agreement;

Borrower means an Original Borrower or an Additional Borrower unless it has ceased to be a Borrower in accordance with clause 21 (Changes to the Obligors and Release of Security) of the Credit Agreement;

C Facility means the revolving loan facility made available under the Credit Agreement as described and defined in paragraph (c) of clause 2.1 (The Facilities) of the Credit Agreement;

C Facility Limit means:

- (a) in relation to each Original Lender, the amount set opposite its name under the heading "C Facility Limit" in Part 2 (The Original Lenders) of Schedule 1 (The Original Parties) to the Credit Agreement and the amount of any other C Facility Limit transferred to it under the Credit Agreement; and
- (b) in relation to any other Lender, the amount of any C Facility Limit transferred to it under the Credit Agreement,

in each case to the extent not cancelled, reduced or transferred by it under the Credit Agreement;

Credit Agreement means the £60,000,000 credit agreement dated 12 January 2009 between (among others) the Chargor and the Security Trustee;
