UPON THE APPLICATION by a Claim Form dated the 31st October 2018 of
Henry Alexander the Claimant and a creditor of the above named Pstores
Realisations Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to
the relief sought by this Claim as appears from the waiver letter from the Treasury
Solicitor dated the 31st December 2018.

AND upon the Claimant by his Solicitors undertaking that he will:

- (A) inform the Registrar of Companies of the title and Court reference
number of the proposed litigation referred to in paragraph 3 of the
Witness Statement of Andrew James dated the 11th October 2018
immediately after issue



- (B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or the conclusion of the claim by any other means

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Pstores Realisations Limited be restored to the Register of Companies
- (2) the Company do continue in Compulsory Liquidation
- (3) the Claimant do serve a copy of the Order on the Official Receiver within 21 days of the date thereof
- (4) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 00290792 Limited
- (5) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

(6) the Registrar of Companies do advertise notice of this Order in her
official name in the "London Gazette"

(7) the hearing fixed for the 21st February 2019 at 2:00pm be vacated
