AND UPON notice of the Application having been given to the Secretary of State

IT IS ORDERED THAT

1. TRANSFER BETWEEN COURTS

1.1 Insofar as the Application concerns cases not currently within the jurisdiction of this Court they be transferred to this Court solely for the purpose of and insofar as is necessary for considering the Application and the making of this Order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this Order.

2. REMOVAL OF MARK TERENCE GETLIFFE AS OFFICE HOLDER

- 2.1 Mark Terence Getliffe be removed as office holder in the cases set out in Schedule 1, 2 and 3 (the "Schedules") hereto pursuant to the relevant power set opposite each category below, with effect from the date of this Order:
 - (a) Creditors' voluntary liquidation cases Section 108 of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
 - (b) Members' voluntary liquidation cases Section 108 of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
 - (c) Compulsory winding up cases Section 172(2) of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
 - (d) Administration cases Paragraph 88 of Schedule B1 to the Insolvency Act 1986 and Rule 12.36(2)(b) of the Insolvency (England and Wales) Rules 2016;
 - (e) Bankruptcy cases Section 298 of the Insolvency Act 1986 and Rule 12.36(2)(c) of the Insolvency (England and Wales) Rules 2016;
- 2.2 Mark Terence Getliffe be removed as the Joint Liquidator of PRJ Limited (in Creditors' Voluntary Liquidation), leaving Margaret Carter of Azets Holdings Limited as the Sole Liquidator.

3. APPOINTMENT OF KERRY PEARSON OR NICOLA KATE CLARK AS REPLACEMENT OFFICE HOLDER

3.1 Kerry Pearson, having filed a statement with the court, stating that she is qualified to act as an insolvency practitioner in the relevant cases and that she consents to act, be appointed in substitution for Mark Terence Getliffe, as joint office holder (namely joint liquidator/administrator/ trustee in bankruptcy) with Nicola Kate Clark in each of the relevant matters set out in Schedule 1 from the date of this Order.

- 3.2 Nicola Kate Clark, having filed a statement with the court, stating that she is qualified to act as an insolvency practitioner in the relevant case and that she consents to act, be appointed in substitution for Mark Terence Getliffe, as Joint Office Holder (namely administrator) with Andrew Hosking in the matter set out in Schedule 2 from the date of this Order.
- 3.3 Mark Terence Getliffe be removed as the Joint Office Holder of the cases listed in Schedule 3 where he is the Joint Office Holder with Diane Elizabeth Hill of Azets Holdings Limited and Nicola Kate Clark to be appointed as the replacement Joint Office Holder.
- 3.4 Any act required or authorised under any enactment to be done by a liquidator, an administrator, or trustee in bankruptcy (as applicable) may be done by all or any one of the respective liquidators, administrators or trustees in bankruptcy (as applicable) in each relevant matter acting jointly or alone.
- 3.5 In the cases where Mark Terence Getliffe is being replaced in the office of administrator, Kerry Pearson or Nicola Kate Clark (as appropriate) shall additionally replace him as the nominated liquidator where and to the extent that Mark Terence Getliffe is referred to as the nominated liquidator for any future liquidation in the relevant Administrators' proposals which have been approved by creditors.

4. ADVERTISEMENT, REPORTING TO CREDITORS AND MEMBERS AND RELEASE

- 4.1 The Applicant shall give notices of this Order to creditors of those estates listed in the Schedule which are listed as being in CVL, Winding up, Administration or Bankruptcy, and to members of those estates listed in the Schedules as being in MVL, by publishing one composite notice relating to the replacement and appointment as detailed in the Schedules in the London Gazette and must do so within 28 days of this Order. This shall be done in substitution for notifying each individual creditor or member (as applicable) on each estate, save to the extent provided for at paragraph 4.4 below.
- 4.2 The Applicant shall give notice to the Secretary of State and the Registrar of Companies in respect of the insolvency proceedings listed in the Schedules of the terms of this Order as soon as reasonably practicable following the making of this Order.
- 4.3 Permission is given to the Secretary of State to apply to vary this Order at any time up to 28 days after the notice referred to in paragraph 4.1 above is published.
- The Applicant shall at the first convenient opportunity and, in any event, when the next routine report is due to the creditors or members of each estate or within twelve months following the

making of this Order, whichever is sooner, notify such creditors or members of the making of this Order, such notice to contain the following matters:

- 4.4.1 an explanation of the effect of this Order;
- 4.4.2 express reference to the liberty to apply contained in paragraph 5.1;
- 4.4.3 In the case of liquidations, where liquidation committees of creditors' committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided has not already been provided as part of the report, it is open to that committee to require the Applicant to provide an account of the administration of the estate, including a summary of receipts and payments and a statement that they have reconciled the accounts;
- 4.4.4 In the case of liquidations where no committees have been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an Order that the Applicants do provide an account of the administration of the estate, including a summary of receipts and payments and a statement that they have reconciled accounts
- 4.4.5 Notification that if the replacement joint office holder has been required to provide the information referred to in 4.4.3 and 4.4.4 above, whether by a committee of by court order on the application of any creditor, the cost of the replacement joint office holder of so complying will, unless there be good reason to the contrary, be paid as an expense of the winding up, administration or bankruptcy as the case may be; and
