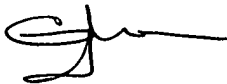

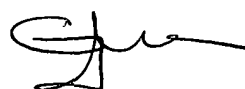
The Company did not trade during the year.

NOTES FORMING PART OF THE ACCOUNTS

1. COMPANY INFORMATION

F-M Trademarks Limited is a limited liability company incorporated in England and Wales. Its registered office is at Manchester International Office Centre, Styal Road, Manchester M22 5TN.

2. BASIS OF PREPARATION

These financial statements have been prepared in accordance with applicable United Kingdom accounting standards including Financial Reporting Standard 102, "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland" ("FRS102") and with the Companies Act 2006. As the Company meets the Companies Act definition of a dormant company it has taken transitional relief under FRS102 Para 35.10(m) and chosen to retain its accounting policies for reported assets, liabilities and equity at the date of transition to this FRS until there is any change to those balances or the Company undertakes any new transactions. The financial statements have been prepared on the historical cost basis.

The financial statements are presented in Sterling (£) (the Company's functional currency).

The Company's ultimate parent undertaking is Tenneco Inc, a company incorporated in the USA and listed on the New York Stock Exchange. The Company is included in the consolidated financial statements of Tenneco Inc. Consolidated financial statements of the ultimate parent entity are available from its website www.tenneco.com. Consequently, the Company has taken advantage of the exemption from preparing a cash flow statement under the terms of FRS102.

3. PRINCIPAL ACCOUNTING POLICIES

Debtors
