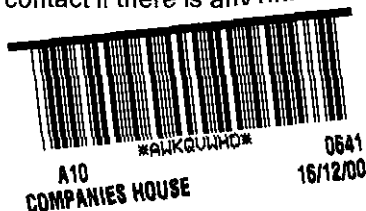

## NOTES
