No director who held office on 31 December 2004 had an interest in the company's shares either during the financial year or at 31 December 2004.


Statement of directors' responsibilities

The smallest such group is that headed by SITA Holdings UK Limited, a company registered in England & Wales. In the opinion of the directors, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of Jacksons (Warwickshire) Brickworks Limited. Suez SA is the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited.
