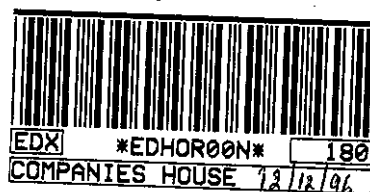
Dear Sirs
