The Company did not carry on any business during the year or the previous year and has not incurred any liabilities. The Company is expected to remain dormant during 2015.

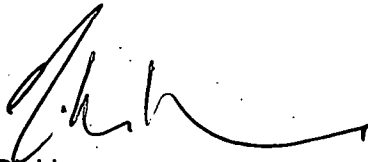

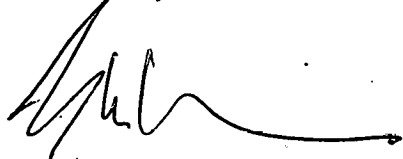
No income statement, statement of comprehensive income or statement of changes in equity has been prepared as the Company has not traded during the year or the preceding financial year. The Directors received no remuneration.

For the year ended 31 December 2014

1. Reporting entity

These financial statements are prepared for Barclays Nominees (Provincial) Limited (the 'Company'), which is dormant. The financial statements are prepared for the Company only. The Company is a wholly owned subsidiary of Barclays Group Holdings Limited and its ultimate parent company is Barclays PLC, which prepares consolidated financial statements in accordance with International Financial Reporting Standards (IFRSs).

The Company is a private limited company, incorporated in the United Kingdom and registered in England.

2. Compliance with International Financial Reporting Standards

The financial statements have been prepared in accordance with International Financial Reporting Standards (IFRSs) and interpretations (IFRICs) issued by the Interpretations Committee, as published by the International Accounting Standards Board (IASB). They are also in accordance with IFRS and IFRIC interpretations endorsed by the European Union, and with those parts of the Companies Act 2006 applicable to Companies reporting under IFRS. The principal accounting policies applied in the preparation of the financial statements are set out below. These policies have been consistently applied.

3. Summary of significant accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention. They are stated in Pounds Sterling (£), the currency of the country in which the Company is incorporated.
