Subject as hereinafter provided, the Regulations contained in Table A in the First Schedule to The Companies Act 1929, shall apply to this Company, Clauses 11, 19, 39, 58, 59, 60, 61, 64, 66, 69, 73 and 74 of Table A shall not apply to the Company, but the remaining Clauses of Table A, subject to the modifications hereinafter expressed, and the Clauses hereinafter contained shall be the Regulations of the Company

- 4 THAT article 2 of the Articles of Association be deleted
- THAT the terms and arrangements contemplated by the execution, delivery and performance by the Company, and the execution by the Company, of the following document be approved
 - a guarantee and debenture to be executed by the Company's parent company, Sporting Club St Helens Limited (Parent) and the Company in favour of Crowther St Holdings Limited pursuant to which each of the Parent and the Company guarantee to Crowther St Holdings Limited the payment and performance by each other of their obligations to Crowther St Holdings Limited and pursuant to which all monies due and to become due from each of the Company and the Parent to Crowther St Holdings Limited are secured by

creating fixed and floating charges over the whole of the assets and undertaking of the Company and the Parent.
