In the event of a winding up, they are entitled to receive no more than the amount paid up, together with a 5 pence premium per share, plus any arrears of dividends (whether earned or declared or not) up to the date of the return of capital

The dividends on these preference shares for the 53 weeks ended 18 September 2010 have been waived

6 Profit and loss account

7 Holding company
