The allotted, called up and fully paid share capital of the company at 31 January 2016 and 2015 comprised 7,302 ordinary shares of £1 each.

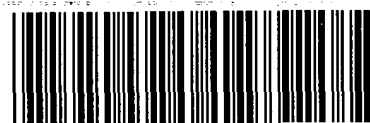
3 Profit and loss account
