1. Reporting entity

Wedd Jefferson (Nominees) Limited (the 'Company') is a dormant private limited company domiciled and incorporated in England and Wales. The Company's registered office is 1 Churchill Place, London, E14 5HP. The financial statements are prepared for the Company, a non-trading company.
