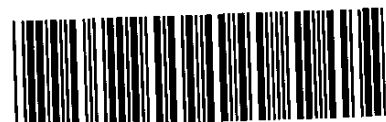


- (1) the name of the above named Bentley & Armstrong Limited be restored to the Register of Companies
