

6 Proposals

- 6.1 It is proposed that the Joint Administrators continue to manage the affairs of the Company in order to achieve the purpose of the Administration. In the circumstances it is proposed that:-
1. The Joint Administrators continue to manage the affairs of the Company.
 2. The Joint Administrators do all such other things and generally exercise all of their powers as contained in Schedules 1 and B1 of the Insolvency Act 1986, as they consider desirable or expedient to achieve the statutory purpose of the Administration.
 3. That the creditors consider establishing a Creditors' Committee and that if any such Committee is formed they be authorised to sanction any proposed act on the part of the Joint Administrators without the need to report back to a further meeting of creditors generally, to include making any decision about the most appropriate exit route from the Administration.
 4. Under Rule 2.106 of the Insolvency (Amendment) Rules 2003 and in the absence of a Creditors' Committee, the remuneration of the Joint Administrators be fixed by reference to time properly spent by them and their staff in attending to matters arising from the Administration.
 5. In accordance with Statement of Insolvency Practice No 9, issued by the Association of Business Recovery Professionals the Joint Administrators be authorised to draw remuneration as and when funds are available on account of their time costs. A creditors' guide to fees is attached as Appendix C.
 6. The Joint Administrators believe there will be sufficient funds to pay secured and preferential creditors in full. If there are then sufficient funds available to pay a dividend to unsecured creditors, the Administrators will file a notice with the Registrar of Companies in order that the Administration will cease and the Company will move automatically into Creditors' Voluntary Liquidation (CVL). It is proposed that the Joint Administrators will also become the Joint Liquidators of the CVL. Under Paragraph 83(7) of Schedule B1 and Rule 2.117(3) to the Insolvency Act 1986, creditors have the right to nominate an alternative liquidator of their choice. To do this, creditors must make their nomination in writing to the Administrators provided that the nomination is made after the receipt of the proposals and prior to these proposals being approved. Where this occurs, the Administrators will advise creditors and provide the opportunity to vote. In the absence of a nomination, the Joint Administrators will automatically become the Joint Liquidators of the subsequent CVL.

7. Once all assets have been realised should there be insufficient funds available to enable a distribution to the unsecured creditors, we propose either:
 - To file a notice pursuant to Paragraph 84 of Schedule B1 together with our final progress report at Court and with the Registrar of Companies for the dissolution of the Company. We shall send copies of these documents to the Company and its creditors. The appointment will end following the registration of the notice by the Registrar of Companies or,
 - To make an application to court pursuant to Paragraph 79(2) of Schedule B1 to the Insolvency Act 1986 for an order that:
 - the appointment of the Joint Administrators ceases to have effect on the date of the determination of the application
 - the Company be wound up by the court under the provisions of the Insolvency Act 1986
 - the Joint Administrators be appointed Joint Liquidators pursuant to Section 140 of the Insolvency Act 1986 and the Joint Administrators be discharged from liability under Paragraph 98(1) of Schedule B1 to the Insolvency Act 1986, with effect from such time as the Court may specify.
8. In the absence of a Creditors' Committee the Joint Administrators will be discharged from liability under Paragraph 98 of Schedule B1 to the Insolvency Act 1986 immediately upon their appointment as Administrators ceasing to have effect.

- 1.1 The Company's registered number is 00448624.
- 1.2 The trading address of the Company is Clayton Business Park, Blackburn Road, Accrington, Lancashire, BB5 5GT.
- 1.3 The registered office of the Company is Clayton Business Park, Blackburn Road, Accrington, Lancashire, BB5 5GT.

- 1.5 The Company was listed on the Stock Exchange and its share capital was owned by nearly 1,000 members. The Company was the holding company for the Gaskell group of Companies ("the Group").

2 Background to the Administration

- 2.1 The Company was incorporated and became a listed Plc in 1948. It initially traded as a felt underlay merchant and then developed into a broadloom carpet manufacturer. It increased its market share through the acquisition of various companies and became an operating holding company.
- 2.2 The Group were leading suppliers of premium branded floorcoverings to the residential and commercial markets. They provided a complete range of floorcoverings which included fibre-bonded, tufted and Axminster.
- 2.3 The Company carried out its operations from leasehold premises in Clayton Business Park, Accrington.

- 2.4 The Group began to experience a downturn in demand for carpets which was in part due to the increased popularity of laminate flooring over the past decade. In 2002 sales of Crucial Trading and Mid Wales Yarns were completed and in 2003 the carpet tile division was disposed of and retail manufacturing ceased at Tomkinson Carpets Limited.
- 2.5 Despite its restructuring efforts, the Group continued to experience losses and creditor pressure increased. The directors identified that the Group was no longer viable in its current form and on 16 February 2005 issued a statement to the Stock Exchange regarding the Group's continued loss making and stated that they were considering options to improve trading performance and strategic alternatives for the Group, including the restructuring of certain parts of the business. Following this announcement the Plc board resolved to market the Group for sale. Although significant interest was generated it became clear that no party was interested in purchasing the Company's shares due to the level of the Company's liabilities.
- 2.6 During February and March 2005 trading became more difficult due to trade creditors requiring ransom payments to continue with necessary supplies. In addition, the directors were unable to reach an agreement on standstill arrangements with the trustees of the Group's pension funds and were unable to secure additional funding required to continue trading.
- 2.7 As a result, Charles Peter Holder and Stuart Charles Edward Mackellar, licensed insolvency practitioners, were appointed Joint Administrators of the Company by the directors pursuant to Paragraph 22 of Schedule B1 of the Insolvency Act 1986 on 18 March 2005. They were also appointed over other Group companies being Gaskell Flooring Limited ("Flooring"), Gaskell Logistics Limited ("Logistics") and Gaskell Logistics (Northern) Limited on 18 March 2005 and Gaskell Carpets Limited on 30 March 2005.
- 2.8 C P Holder is licensed by the Institute of Chartered Accountants in England and Wales (9093) and S C E Mackellar is licensed by the Institute of Chartered Accountants of Scotland (6883).
- 2.9 The Court reference number is 299 of 2005 in the High Court of Justice Chancery Division, Leeds District Registry, 1 Oxford Row, Leeds.
- 2.10 The Company's main centre of operations is based in the United Kingdom. The EC Regulations on Insolvency Proceedings 2000 apply to the Administration. The proceedings are main proceedings as defined by Article 3 of those Regulations.
- 2.11 The Joint Administrators act jointly and severally so that all functions may be exercised by either Administrator.

- 2.12 The Joint Administrators of the Company must perform their functions with the purpose of achieving one of the following objectives:
- Rescuing the Company as a going concern; or
 - Achieving a better result for the Company's creditors as a whole than would be likely if the Company were wound up (without first being in Administration); or
 - Realising property in order to make a distribution to one or more secured or preferential creditors.
- 2.13 The first objective under the new Administration regime is based on the survival of the existing Company through a Company Voluntary Arrangement (CVA) or a Scheme of Arrangement under Section 425 of the Companies Act. Due to the high level of creditor claims the survival of the existing Company via a CVA or S425 scheme of arrangement was not achievable. The Joint Administrators therefore pursued the second objective of achieving a better result for creditors than would be likely if the Company were wound up.

3 Administration Strategy

- 3.1 The Joint Administrators identified that it would not be possible to rescue the Company as a going concern and therefore decided to pursue the second objective of achieving a better return for the creditors than would be likely if the Company were wound up.
- 3.2 A decision was made to trade the subsidiary companies Flooring and Logistics, while sales of the Group's businesses were achieved. The Joint Administrators secured funding from Barclays Bank Plc ("the Bank") which enabled them to trade in the short term.
- 3.3 The Joint Administrators approached the interested parties which had been identified during the marketing exercise completed by the directors prior to appointment and began negotiations. The Joint Administrators also placed an advert in the Financial Times on 22 March 2005 which resulted in further expressions of interest.
- 3.4 The Company owned a freehold property at Wheatfield Mill, Parker Street, Rishton, Blackburn, Lancashire. The manufacturing and office premises were used by Flooring primarily for the manufacture of contract carpets.
- 3.5 The freehold property was sold for £1,400,000 to Ever 2552 Limited on 4 April 2005 as part of the Flooring contract sale. The purchase was led by the Company's managing director Gerry Wheeler and backed by EPIC Reconstruction plc.
- 3.6 The Company had 6 employees of which 2 were made redundant immediately upon appointment and the remaining 4 transferred to Ever 2552 Limited on 4 April 2005.

- 3.7 The Company has an inter-company debt due from Flooring of £4,641,000 and £151,000 from Logistics. It is possible that dividends may in due course be made from Flooring and Logistics however it is not possible at this stage to indicate the quantum or timing of any dividend.
- 3.8 The Joint Administrators are proposing in Section 6.1 that they continue to manage the affairs of the Company. This work will include:
- Dealing with employee queries and the Redundancy Payments Office.
 - Dealing with statutory reporting and compliance obligations.
 - Making payments to the Company's secured and preferential creditors.
 - Conducting investigations into the conduct of the directors of the Company and reporting to the Department of Trade and Industry pursuant to the Company Directors Disqualification Act.

4 Administrators' Receipts and Payments

- 4.1 A summary of receipts and payments for the Administration period from the date of our appointment to 9 May 2005 is attached as Appendix A.
- 4.2 The receipts and payments account shows that the Joint Administrators have made an interim distribution to the secured chargeholder, the Bank under its fixed charge. All assets relating to the Company have been realised and no future realisations are anticipated.

5 Financial position of the Company

- 5.1 Attached as Appendix B is a summary of the Directors' Estimated Statement of Affairs of the Company as at the date of the appointment of the Joint Administrators.

7 Administrators' Remuneration

- 7.1 It is proposed that the remuneration of the Joint Administrators will be fixed by reference to time spent by them and their staff in managing the Administration, in accordance with the Statement of Insolvency Practice No.9 issued by the Association of Business Recovery Professionals. A copy of the 'Creditors' Guide to Administrators' Fees' is attached as Appendix C.
- 7.2 The Joint Administrators time costs at 9 May 2005 are £73,805. We have attached as Appendix D a Time Analysis in accordance with the provisions of SIP 9, which provides details of the activity costs incurred by staff grade to the above date. We propose drawing fees in accordance with the proposals outlined above.
- 7.3 Attached as Appendix E is additional information in relation to our policy on staffing, the use of subcontractors, disbursements and details of our current charge-out rates by staff grade. A description of the work involved under the main activity codes of SIP 9 are detailed below:

Administration and Planning

The work which is involved within this area is dealing with the statutory duties of the Administration and reporting to creditors. In addition time spent formulating the strategy for the progression of the Administration (including internal meetings) is recorded here as are travel and administration time.

Realisation of Assets

The time incurred here is dealing with the sale of the relevant assets of the Company.

Trading

The time spent here included managing the day to day trading of the Company to ensure that a sale of the businesses as going concerns was achieved. Time has also been spent reconciling and finalising the trading account.

Creditors

This reflects the time spent with employees and other creditors of the Company, including meetings and telephone calls.

8 Estimated Outcome

- 8.1 Based on the Directors' Estimated Statement of Affairs attached to this report the estimated value of the preferential creditors is £5,000 and the unsecured creditors is £8,229,000. The unsecured creditors figure includes the directors' estimate of £882,000 for the Gaskell Pension Scheme. This scheme is a final salary scheme and we are currently seeking advice in order to establish that a liability from this scheme will be held against the Company as a participating employer.
- 8.2 The Bank hold fixed and floating charge security in relation to lending made to the Group. Their total debt from the Group was approximately £1,903,000 at the date of appointment.
- 8.3 It is anticipated that the Bank and preferential creditors will be paid in full and that there may be sufficient funds to make a distribution to unsecured creditors.
- 8.4 As the security pre-dates the introduction of the Enterprise Act 2002 on 15 September 2003, there is no requirement to set aside an 'Unsecured Creditors' Fund' as outlined in s176A of the Act.

9 Next Report

- 9.1 The Joint Administrators are required to provide a progress report within one month of the end of the first six months of the Administration.

10 Meeting of Creditors

- 10.1 An initial meeting of the Company's creditors is being convened to approve the Joint Administrators' proposals. The meeting will be held on 26 May 2005 at 2.30pm at The Village Hotel and Leisure Club, Bury.

Appendix C

**A CREDITORS' GUIDE TO ADMINISTRATORS' FEES
ENGLAND AND WALES**

1 Introduction

- 1.1 When a company goes into Administration the costs of the proceedings are paid out of its assets. The creditors, who hope eventually to recover some of their debts out of the assets, therefore have a direct interest in the level of costs, and in particular the remuneration of the insolvency practitioner appointed to act as Administrator. The insolvency legislation recognises this interest by providing mechanisms for creditors to determine the basis of the Administrators' fees. This guide is intended to help creditors be aware of their rights under the legislation to approve and monitor fees and explains the basis on which fees are fixed.

2 The nature of Administration

- 2.1 Administration is a procedure which places a company under the control of an insolvency practitioner and the protection of the court in order to achieve one or more of the following statutory purposes:

- Rescuing the Company as a going concern; or
- Achieving a better result for the Company's creditors as a whole than would be likely if the Company were wound up (without first being in Administration); or
- Realising property in order to make a distribution to one or more secured or preferential creditors.

Administration may be followed by a company voluntary arrangement, liquidation, dissolution or survival of the Company.

3 The Creditors' Committee

- 3.1 The creditors have the right to appoint a committee with a minimum of 3 and a maximum of 5 members. One of the functions of the committee is to determine the basis of the Administrators' remuneration. The committee is established at the meeting of creditors, which the Administrator is required to hold within 10 weeks of the commencement of the Administration to consider his proposals (subject to certain conditions). The Administrator must call the first meeting of the committee within 6 weeks of its establishment, and subsequent meetings must be held either at specified dates agreed by the committee, or when a member of the committee asks for one, or when the Administrator decides he needs to hold one. The committee has the power to summon the Administrator to attend before it and provide such information as it may require.

4 Fixing the Administrators' fees

- 4.1 The basis for fixing the Administrators' remuneration is set out in Rule 2.106 of the Insolvency (Amendment) Rules 2003, which states that it shall be fixed either:
- as a percentage of the value of the property which the Administrator has to deal with, or
 - by reference to the time properly given by the Administrator and his staff in attending to matters arising in the Administration;

It is for the creditors' committee (if there is one) to determine on which of these bases the remuneration is to be fixed, and if it is fixed as a percentage, to fix the percentage to be applied. Rule 2.106 says that in arriving at its decision the committee shall have regard to the following matters:

- the complexity (or otherwise) of the case;
 - any responsibility of an exceptional kind or degree which falls on the Administrator;
 - the effectiveness with which the Administrator appears to be carrying out, or to have carried out, his duties;
 - the value and nature of the property which the Administrator has to deal with;
- 4.2 If there is no creditors' committee, or the committee does not make the requisite determination, the Administrators' remuneration may be fixed by a resolution of a meeting of creditors having regard to the same matters as the committee would. If the remuneration is not fixed in any of these ways, it will be fixed by the court on application by the Administrator.

5 What Information should be provided by the Administrator?**5.1 When seeking fee approval**

5.1.1. *When seeking agreement to his fees the Administrator should provide sufficient supporting information to enable the committee or the creditors to form a judgement as to whether the proposed fee is reasonable having regard to all the circumstances of the case. The nature and extent of the supporting information which should be provided will depend on:*

- the nature of the approval being sought;
- the stage during the Administration of the case at which it is being sought; and
- the size and complexity of the case.

5.1.2. *Where, at any creditors' or committee meeting, the Administrator seeks agreement to the terms on which he is to be remunerated, he should provide the meeting with details of the charge-out rates of all grades of staff, including principals, which are likely to be involved on the case.*

5.1.3. *Where the Administrator seeks agreement to his fees during the course of the Administration, he should always provide an up to date receipts and payments account. Where the proposed fee is based on time costs the Administrator should disclose to the committee or the creditors the time spent and the charge-out value in the particular case, together with, where appropriate, such additional information as may reasonably be required having regard to the size and complexity of the case. The additional information should comprise a sufficient explanation of what the Administrator has achieved and how it was achieved to enable the value of the exercise to be assessed (whilst recognising that the Administrator must fulfil certain statutory obligations that might be seen to bring no value for creditors) and to establish that the time has been properly spent on the case. That assessment will need to be made having regard to the time spent and the rates at which that time was charged, bearing in mind the factors set out in paragraph 4.1 above. To enable this assessment to be carried out it may be necessary for the Administrator to provide an analysis of the time spent on the case by type of activity and grade of staff. The degree of detail will depend on the circumstances of the case, but it will be helpful to be aware of the professional guidance which has been given to insolvency practitioners on this subject. The guidance suggests the following areas of activity as a basis for the analysis of time spent:*

- Administration and planning
- Investigations
- Realisation of assets
- Trading

- Creditors
- Any other case-specific matters

The following categories are suggested as a basis for analysis by grade of staff:

- Partner
- Manager
- Other senior professionals
- Assistants and support staff

The explanation of what has been done can be expected to include an outline of the nature of the assignment and the Administrator's own initial assessment, including the anticipated return to creditors. To the extent applicable it should also explain:

- Any significant aspects of the case, particularly those that affect the amount of time spent.
- The reasons for subsequent changes in strategy.
- Any comments on any figures in the summary of time spent accompanying the request the Administrator wishes to make.
- The steps taken to establish the views of creditors, particularly in relation to agreeing the strategy for the assignment, budgeting, time recording, fee drawing or fee agreement.
- Any existing agreement about fees.
- Details of how other professionals, including subcontractors, were chosen, how they were contracted to be paid, and what steps have been taken to review their fees.

It should be borne in mind that the degree of analysis and form of presentation should be proportionate to the size and complexity of the case. In smaller cases not all categories of activity will always be relevant, whilst further analysis may be necessary in larger cases.

- 5.1.4. *Where the fee is charged on a percentage basis the Administrator should provide details of any work which has been or is intended to be sub-contracted out which would normally be undertaken directly by an Administrator or his staff.*

5.2 After fee approval

Where a resolution fixing the basis of fees is passed at any creditors' meeting held before he has substantially completed his functions, the Administrator should notify the creditors of the details of the resolution in his next report or circular to them. In all subsequent reports to creditors the Administrator should specify the amount of remuneration he has drawn in accordance with the resolution. Where the fee is based on time costs he should also provide details of the time spent and charge-out value to date and any material changes in the rates charged for the various grades since the resolution was first passed. He should also provide such additional information as may be required in accordance with the principles set out in paragraph 5.1.3. Where the fee is charged on a percentage basis the Administrator should provide the details set out in paragraph 5.1.4 above regarding the work which has been subcontracted out.

5.3 Expenses and disbursements

There is no statutory requirement for the committee or the creditors to approve the drawing of expenses or disbursements. However, professional guidance issued to insolvency practitioners requires that, where the Administrator proposes to recover costs which, whilst being in the nature of expenses or disbursements, may include an element of shared or allocated costs (such as room hire, document storage or communication facilities provided by the Administrator's own firm), they must be disclosed and be authorised by those responsible for approving his remuneration. Such expenses must be directly incurred on the case and subject to a reasonable method of calculation and allocation.

6 What if a creditor is dissatisfied?

- 6.1** If a creditor believes that the Administrator's remuneration is too high he may, if at least 25 per cent in value of the creditors (including himself) agree, apply to the court for an order that it be reduced. If the court does not dismiss the application (which it may if it considers that insufficient cause is shown) the applicant must give the Administrator a copy of the application and supporting evidence at least 14 days before the hearing. Unless the court orders otherwise, the costs must be paid by the applicant and not as an expense of the Administration.

7 What if the Administrator is dissatisfied?

- 7.1 If the Administrator considers that the remuneration fixed by the creditors' committee is insufficient he may request that it be increased by resolution of the creditors. If he considers that the remuneration fixed by the committee or the creditors is insufficient, he may apply to the court for it to be increased. If he decides to apply to the court he must give at least 14 days' notice to the members of the creditors' committee and the committee may nominate one or more of its members to appear or be represented on the application. If there is no committee, the Administrator's notice of his application must be sent to such of the company's creditors as the court may direct, and they may nominate one or more of their number to appear or be represented. The court may order the costs to be paid as an expense of the Administration.

8 Other matters relating to fees

- 8.1 Where there are Joint Administrators it is for them to agree between themselves how the remuneration payable should be apportioned. Any dispute arising between them may be referred to the court, the creditors' committee or a meeting of creditors.
- 8.2 If the Administrator is a solicitor and employs his own firm to act on behalf of the company, profit costs may not be paid unless authorised by the creditors' committee, the creditors or the court.

Appendix E

**ADDITIONAL INFORMATION IN RELATION TO ADMINISTRATORS' FEES
PURSUANT TO STATEMENT OF INSOLVENCY PRACTICE 9**

1 Policy

Detailed below is Kroll's policy in relation to:

- Staff allocation and the use of subcontractors
- Professional advisors
- Disbursements

1.1 Staff allocation and the use of subcontractors

Our general approach to resourcing our assignments is to allocate staff with the skills and experience to meet the specific requirements of the case.

The constitution of the case team will usually consist of a Partner, Manager, Senior and Assistant. The exact constitution of the case team will depend on the anticipated size and complexity of the assignment and on larger, more complex cases, several Seniors/Assistants may be allocated to meet the demands of the case.

With regard to support staff, we would advise that time spent by cashiers in relation to specific tasks on an assignment is charged. Only if there is a large block of time incurred by a member of the secretarial team, e.g. report compilation and distribution, do we seek to charge and recover our time in this regard.

We have not utilised the services of any subcontractors in this case.

1.2 Professional advisors

On this assignment we have used the professional advisors listed below. We have also indicated alongside, the basis of our fee arrangement with them, which is subject to review on a regular basis.

Our choice was based on our perception of their experience and ability to perform this type of work, the complexity and nature of the assignment and the basis of our fee arrangement with them.

1.3 Disbursements

Category 1 disbursements do not require approval by creditors. The type of disbursements that may be charged as a Category 1 disbursement to a case generally comprise of external supplies of incidental services specifically identifiable to the case, such as postage, case advertising, invoiced travel and external printing, room hire and document storage. Also chargeable will be any properly reimbursed expenses incurred by personnel in connection with the case.

Category 2 disbursements do require approval from creditors. These disbursements can include costs incurred which relate to payments due to associated companies for the provision of services to the office holder. There have been no Category 2 disbursements charged on this case.

2 Charge-out rates

Complex charge-out rates have been applied to this assignment due to its size and complexity.
