STATEMENT OF DIRECTORS' RESPONSIBILITIES

We have audited the financial statements of the Brentwood Roman Catholic Diocese Trustee for the year ended 5 April 2012 which comprise the Profit and Loss Account, the Balance Sheet, and the related notes. - have been prepared in accordance with the requirements of the Companies Act 2006.


Opinion on other matter prescribed by the Companies Act 2006




