---

**UPON** the Application of Simon Vincent Freakley and Peter Mark Saville for a block transfer order dated March 2022

**AND UPON READING** the evidence on the court file.

**AND UPON** the court dealing with this application without a hearing pursuant to rule 12.38(1) of the Insolvency (England and Wales) Rules 2016 ("**Rules**").

**IT IS ORDERED THAT:**

1. Simon Vincent Freakley and Peter Mark Saville (the "**outgoing office-holders**") be removed from office in respect of each of the on-going cases listed in Part 1 and Part 2 of the Schedule attached (the "**block transfer cases**") from the date of this order.
2. Alastair Paul Beveridge, Catherine Mary Williamson and Clare Kennedy ("the **replacement office holders**") be appointed as joint replacement office-holders in respect of the block transfer case listed in Part 1 and Part 2 of the Schedule from the date of this order.
3. The creditors in each of the block transfer cases shall be notified of this order by one composite advertisement published in the London Gazette within 21 days from the date of this

order. An advertisement containing the information set out in the Schedule shall be sufficient to comply with the requirements of rule 1.6 and Chapter 4 of Part 1 (rules 1.10 to 1.14) of the Rules.

4. Any creditor in respect of any of the block transfer cases listed in the Schedule who has an objection to this order shall have 21 days from the date of the publication of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in the Schedule unless otherwise ordered by the court.
5. The first replacement office-holder, the second replacement office-holder and the third replacement office-holder (together the **"replacement office-holders"**) shall as soon as reasonably practicable give notice of the terms of this order to the Secretary of State and to the Registrar of Companies.
6. The outgoing office-holders shall file a copy of this order with each of the courts listed in the Schedule.
7. The outgoing office-holders shall receive their release as administrator or liquidator 21 days after the date of the publication of the advertisement referred to at paragraph 3 of this order, save that such release may be subject to further order in the event of an application by any creditor under paragraph 4 of this order, in so far as his release relates to the specific case which is subject to that application.
8. The outgoing office-holders shall receive their release as provided for under paragraph 7 of this order without being required to (i) apply to the Secretary of State for their release or discharge as appropriate pursuant to s.174(4)(b) of the Insolvency Act 1986 as the case may be or (ii) being required to file a receipts and payments account.
9. In respect of any of the block transfer cases where the replacement office-holder is appointed as joint office-holder, any act required or authorised to be done by the joint office-holders may be done by all or any one or more of them.
10. Liberty to apply.
11. No order as to costs
