- (1) THE ENTITIES listed in Schedule 1 (The Chargors) (each a "Chargor"); and
- (2) **DEUTSCHE BANK AG, LONDON BRANCH** as security trustee for itself and the other Secured Parties (the "Security Agent").

#### THIS DEED WITNESSES as follows:

#### 1. **DEFINITIONS**

Terms defined in the Security Agreement (as defined below) shall have the same meanings when used in this deed.

"Security Agreement" means the security agreement governed by Northern Irish law dated 13 August 2021 between, amongst others, the Chargors and the Security Agent.

#### 2. CONSTRUCTION

Clauses 1.2 (Construction) to 1.5 (Miscellaneous) of the Security Agreement will be deemed to be set out in full in this deed, but as if references in those clauses to the Security Agreement were references to this deed.

#### 3. LEGAL CHARGE

Each Chargor as beneficial owner, charges in favour of the Security Agent (as trustee for the Secured Parties), for the payment and discharge of the Secured Obligations, by way of first fixed charge, the Real Property specified in Schedule 2 (*Material Real Property*) to this Charge title to which is registered or registerable in the Land Registry of Northern Ireland pursuant to the provisions of the Land Registration Act (Northern Ireland) 1970 ("Mortgaged Property").

## 4. APPLICATION TO THE LAND REGISTRY

Each Chargor consents and agrees to an application being made to the Land Registry of Northern Ireland to enter the following inhibition in the relevant Folio(s) of any registered land forming the Mortgaged Property:

"No disposition of the registered land by the registered owner of the registered land or by the registered owner of any registered charge, not being a charge registered before the entry of this inhibition, is to be registered without a written consent signed by the registered owner for the time being of the charge dated [ •] in favour of Deutsche Bank AG, London Branch."

#### 5. GOVERNING LAW AND JURISDICTION

This deed and any non-contractual obligations arising out of or in connection with it are governed by the laws of Northern Ireland and the parties agree that the courts of Northern Ireland have exclusive jurisdiction to settle any dispute arising out of or in connection with this

deed (including a dispute regarding the existence, validity or termination of this deed or the consequences of its nullity or any non-contractual obligations arising out of or in connection with it).

THIS CHARGE has been executed and delivered as, and is intended to take effect as, a deed by each Chargor and has been signed by the Security Agent on the date written on the first page of this Legal Charge.


