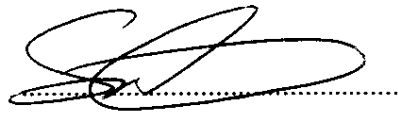


**Agreement under sections 394A and 448A of the Companies Act 2006 (the "Act")**
