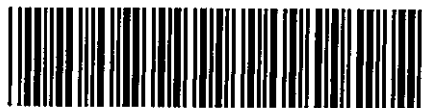

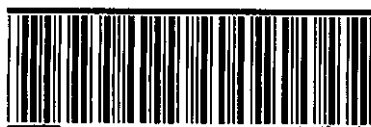

NOTES
