- (5) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off


(6) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

AND UPON the Solicitor for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

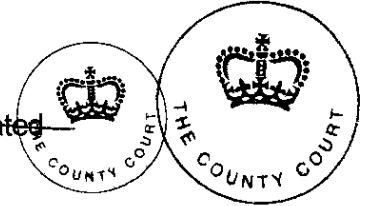
IT IS ORDERED that:
