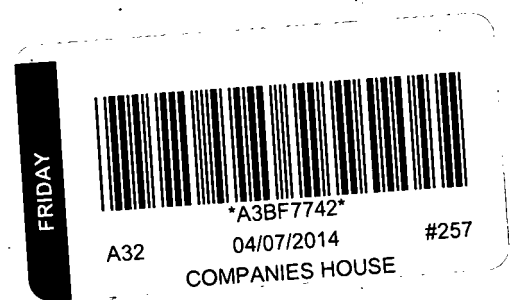



NOTES TO THE ACCOUNTS

1. **Accounting Policy - Basis of Accounting**
The accounts have been prepared under the historical cost convention and in accordance with applicable Accounting Standards.
2. **Profit and Loss Account**
The company did not trade during the year and consequently no profit and loss account has been prepared.
3. **Parent Company and Ultimate Controlling Party**
The immediate parent company is Crest Nicholson Plc, which is incorporated in Great Britain and registered in England and Wales.

The ultimate parent company is Crest Nicholson Holdings plc, the largest higher group of undertakings for which group accounts are drawn up, which is incorporated in Great Britain and registered in England and Wales. Crest Nicholson Holdings plc is the highest group entity in which the results of the group are consolidated. The smallest group in which they are consolidated is that headed by Crest Nicholson Plc.
