CONTRIBUTION AND TRANSFER AGREEMENT

for the transfer of the assets and liabilities of Prudential-Bache Securities (Holland) Inc.

THIS AGREEMENT is made on April 26, 2002 between:

(1) Prudential-Bache Securities (Holland) Inc. (company number 11-3161723) office is at 199 Water Street, New York, NY 10292 USA (the "PBSH")

and

(2) Prudential-Bache International Limited (company number 512397), whose registered office is at 9 Devonshire Square, London, EC2M 4HP ("PBIL").

WHEREAS:

- (A) PBSH is the beneficial owner, subject to any and all liabilities and obligations of whatever type or description, of all of the assets and liabilities, rights, interests, properties and assets of every nature and description, tangible and intangible, held by and in its name and as more particularly described in Appendix B ("PBSH") (the "PBSH Net Assets") including but not limited to any and all of PBSH's real properties, notes and other receivables, contracts, insurance and other claims, prepaid charges, stock, bonds and other securities, cash and cash accounts, and all contracts between PBSH and any other party or parties of every kind and description. For the avoidance of doubt the rights and obligations arising from employment relationships (including pension arrangements) with former employees of PBSH are excluded from the transfer to PBIL and remain with PBSH notwithstanding that the entirety of the PBSH Net Assets are transferred (including provisions in the balance sheet of PBSH for any liabilities related thereto).
- (B) PBSH desires to transfer to PBIL the PBSH Net Assets in exchange for such number of shares of PBIL's share capital as are equivalent to the net asset value of the PBSH Net Assets based on the certification of the net asset value of the PBSH Net Assets by the European Finance Department of PBSH as at the close of business London time on April 26, 2002 and the prevailing foreign exchange rates of conversion in effect at the time of the transfer.
- (C) The boards of directors of PBSH and PBIL, respectively, have authorised PBSH and PBIL to enter into this Agreement.

NOW IT IS AGREED as follows:

TRANSFER OF THE PBSH NET ASSETS PERSONNEL AND PRICE

- 1.1 PBSH shall transfer to PBIL the PBSH Net Assets as more particularly described in Appendix B together with all rights and obligations which now are, or at any time hereafter may become, attached to them. This transfer shall not include the rights and obligations arising from employment relationships (including pension arrangements) with former employees of PBSH which remain with PBSH notwithstanding that the entirety of the PBSH Net Assets are transferred (including provisions in the balance sheet of PBSH for any liabilities related thereto).
- 1.2 PBSH shall transfer to PBIL the PBSH personnel listed on the Schedule attached hereto as Appendix A, with current vested rights that remain unaffected and PBIL shall assume all of the liabilities and obligations of PBSH including but not limited to liabilities and obligations arising under and relating to the PBSH Net-Assets and PBIL represents to PBSH that it currently possesses sufficient financial ability to assure the satisfaction of any liability or performance of

- any such obligations.
- 1.3 The consideration for the transfer of the PBSH Net Assets to PBIL by PBSH will be the allotment of PBIL's shares at net asset value to PBSH on or around May 8, 2002, or at such later date as may be mutually agreed between PBSH and PBIL, following the certification of the net asset value of the PBSH Net Assets by the European Finance Department.

COMPLETION

 The transfer of the PBSH Net Assets shall be completed at 12:01 a.m. London time on April 27, 2002 after the signing of this Agreement when PBSH shall deliver or cause to be delivered to PBIL all the PBSH Net Assets.

COSTS

3. Each of the parties hereto shall pay its own costs, charges and other expenses connected with the negotiation, preparation and implementation of this Agreement and PBSH shall pay all, if any, stamp duty on the transfer of the PBSH Net Assets.

NOTICES

4. Any notice under this Agreement shall be in writing and signed by or on behalf of the party giving it and may be served by leaving it or sending it by telex, facsimile, prepaid recorded delivery or registered post to the address of the relevant party set out at the head of this Agreement.

5. **EXECUTION, GOVERNING LAW AND JURISDICTION**

- Nothing in this agreement is intended to confer on any person any right to enforce any term of this agreement which that person would not have had but for the Contract (Rights of Third Parties) Act 1999.
- 5.2 This agreement may be executed in any number of counterparts, and by each party hereto on separate counterparts, each of which when so executed shall be deemed an original but all the counterparts together constitute one and the same document.
- 5.3 Each of the parties hereby irrevocably submits to the non-exclusive jurisdiction of the courts of England.
- 5.4 This agreement is governed by, and shall be construed in accordance with, the laws of England.
