


The company did not trade during the current or preceding year and has made neither profit nor loss, nor any other recognised gain or loss.

1 Accounting policy

The accounts are prepared under the historical cost convention and are prepared in accordance with applicable United Kingdom accounting standards.

There have been no movements in shareholders' funds during the year under review or the preceding financial year.

4 Contingent liabilities
